(Head of Forest Force) Maharashtra State revoked the said order passed by then Conservator of Forests, Pune for the reasons of non-fulfillment of condition no.15 in the final approval granted by MoEF&CC and also ordered user agency not to start any work over the said area and not to divert the said land to user agency until any further orders are passed by the State Government.
