
Sir,

It is submitted that a proposal (Proposal No. FP/JK/ROAD/43519/2020) for diversion of forest land measuring 0.9875 hectares is in process for construction of road from Udhampur-Ghordi in Km 13<sup>th</sup> to 26<sup>th</sup> from single lane to double lane.

In this regard, a certificate regarding whether or not recognised rights of primitive rival groups (PTG) and pre-agricultural communities (PAC) under forest right act 2006 shall be affected in case of forest land measuring 0.9875 hectares is diverted for proposed non forest purpose requires to be uploaded directly from your office after obtaining information from concerned DFO Udhampur.

As such, you are requested to provide the information directly on forest department Parvesh Portal. So that forest clearance case could be processed further.
