Reproduced below is the relevant extracts from the minutes of 375th meeting of Board of Directors of Coal India Limited held on 12th Nov. 2018 at CIL (H/Q), New Town, Kolkata with regard to the following item:

"ITEM No.375:4(C)

Sub:- Project Report of Bharatpur Reorganization OCP (20 Mty).

- RD, CMPDIL, RI-VIII made presentation. He apprised that -4.3
 - a) Bharatpur OC Expansion is an on-going Project at Talcher Coalfields with a sanctioned capacity of 20 Mty. During 2017-18 it produced 15.03 MT and made a profit of Rs.551.12 per tonne.
 - b) Around 123 Ha of land was given to Jaganath OCP for its sustenance. Hence the balance life of Bharatpur OCP was reduced to 7 years from 1st April'2018. The re-organization of Bharatpur OCP PR was prepared annexing the virgin property of 846 Ha of Kalinga East Block to provide additional life to Bharatpur OCP.
 - c) By this process, 483 MT. of coal reserve was added and life of Bharatpur Reorganisation OCP was enhanced to 32 years.
 - d) To a query, they clarified that EC for 20 MTY is available against the existing project. However, fresh EC for 20 MTY (Peak Capacity 26 MTY) is to be obtained as the re-organisation of the project involved additional requirement of land.
 - e) Additional 912.36 Ha of Land is required which included Forest Land of 69.88 Ha.
 - f) A total of 1093 project affected families are to be rehabilitated from 10 villages. Necessary capital provision had been included in the Project Report.
