As per Reference Letter No. 1 it is mentioned that, “The Proposed bridge site is not a part of any sanctuary or National Park but major part of the project is within notified ESZ of Thane Creek Flamingo Sanctuary Although any major impact of the proposed activity on the avifauna is not perceived during construction or post construction of the bridge, a regular bird survey should be carried out in the area, and if any disturbance to habitat is noticed a contingency plan should be prepared by the User Agency in consultation with Additional Principal Chief Conservator of Forests, Mangrove Cell Mumbai and all the recommendation of the plan should be implemented by User Agency An undertaking on this shall be obtained from the User Agency”. For this, the project proponent is giving an undertaking in this regard to the Additional Principal Chief Conservator of Forests, Mangrove Cell, Mumbai and will be consulted for the taking measures to remove the habitat disturbance.
