Please refer to the Govt. of India Ministry of Environment and Forest and Climate Change, Shimla - office letter dated 22-09-2021.addressed to Nodal Officer and Chief Conservator of Forest (FCA) Taland Shimla on the captioned subject vide which some observations have been raised on the proposal submitted for the approval of Ministry of Environment and Forest. The point wise reply of attended observations is as under:-

Sr. No.	Observation	Reply
1.	Two locations of broken areas mentioned in KML file are having length & width of 630 meters x 5.68 meter and 4.72 meter x 5.68 meter respectively. It is clear from these locations that total broken area is 0.625 hac. However, as per Site Inspection Report Of DFO, Mandi. broken area is 0.3408 hac. The State Government	is 630 m and 472 m which is correct. Therefore the total broken area taken in the

1	may provide clarification in this regard.	
2	It has been observed from the KML file that Kothi village and area opposite to Kothi village are already connected to road. The State Government may justify the proposed alignment as these areas are already connected to the road, along with the comment of concerned Divisional Forest Officer.	Kothi village & area opposite to Kothi village are connected with jeepable roads constructed by local panchayat /public in an unplanned manner and not as per I.R.C standards. The proposed alignment passes through whole Kothi village and its surroundings and it will connect all left out the habitations in the area, while the jeepable roads already constructed by local panchayat touches the particular locations of the villages. The proposed road alignment is as per I.R.C standards. The proposed road will connect Tanda, Balt, Kareri, Kawalkot, Kothi, Sidhyani villages /habitation and it will serve approx. 3737 population. It will connect left out area, which is deprived with road facility. The road is urgently required as people of these villages are facing great hardships to reach the nearby town Ner Chowk. After construction of this road they will connect directly with Medical College Hospital Nerchowk, Market center Ratti and Nerchowk.
