1	As per the part-II report furnished by DFO, Kalahandi (N) Division, the extent of revenue forest land involved in the project is 1.014 ha. but in abstract of Revenue Forest Land schedule furnished by Addl. Tahasildar, Kesinga, countersigned by DFO Kalahandi(N) Division, it has been mentioned to be 1.026 Ha.	Complied
2	Tree enumeration list over Forest land & Non forest land involved in the project pertaining to Bolangir Division, has not been furnished with the proposal. However DFO, Bolangir Division, in his site inspection report has mentioned that 12531 nos. of trees in private land & 2828 nos. of trees in forest land involved in the project are required to be felled & the project proponent has furnished an undertaking to submit tree enumeration list over the forest land involved in the project after obtaining orders from DFOs concerned.	Complied
3	The DGPS map of Uparjhar village (sheet 3) of Bolangir Division showing line of transmission line & land proposed for diversion has neither been signed by Tahasildar concerned nor DFO, Bolangir Division. Further, the cadastral map of Uparjhar village (Sheet -3) shows running of the project through Revenue forest but it has been captioned as Reserve forest.	Complied
