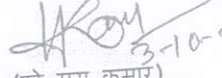

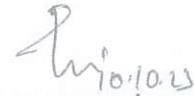

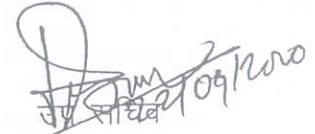

5. कार्य आयोजना के उक्त प्रावधान एवं अन्य (1–18) का पालन सुनिश्चित करने की शर्त पर स्वीकृति की अनुशंसा की जाती है। एवं अनाधिकृत अतिक्रमित क्षेत्र में पानी की पाईन लाईन बिछाने की अनुशंसा नहीं की जाती है।

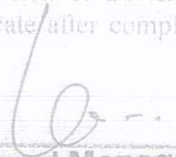
