It is to inform you that National Highways Authority of India (NHAI), under Ministry of Road Transport & Highways, Govt. of India has taken up the upgradation work for 4-laning of Ghazipur-Ballia-UP/Bihar Section from Km. 0.000 to Km. 117.120 (Green Field Alignment) including Buxar Spur (length: 17.270 Km.) of NH-31 in the State of Uttar Pradesh. The length of project road is 134.390 km. The Proposed Right of Way (PROW) is 60m for Greenfield and 45m for existing stretch for subject project.
