In compliance of the Ministry of Environment and Forest (MoEF). Government of India's letter No. 11-9/98-FC(pt.) dated 3<sup>rd</sup> August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006 ('FRA' for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5<sup>th</sup> February 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that 20.342 Ha. Forest Land, & 1.089 Ha. of Revenue forest land, Total Area 21.431 Hectare land proposed to be diverted in favour of CEO, Chhattisgarh Infotech Promotion Society (CHIPS) Raipur, C.G. for laying Optical Fiber Cable in BharatNet Project work in Korba district falls within jurisdiction of *Gurasiya, Sarbhonka, Amakhokhra, Rampur, Nagoikutesar, Barbaspur, Podigosai, Bankehatka, Putuwa, Katorinagoi, Sirki, Jatga, Langa, Basin, Chandroti, Karra, Langi, Amghar, Pipariya, Smlai, Sirri, Khodari, Chindiya, Damhamuda, Ghonsra, Sarma, Podikhurd village in Podiuproda Tehsils; and Forest Land Area(Vankhand)- Gurasiya, Banjari, Madai, Hadmor, Pachara, Bango, Aitmanagar, Bandhapara, Riganiya, Machadoli, Morga, Gajak, Ketma, Sagbadi, Kendai, Arsiya, Paturiyadand, Uchlenga, Gidhmuri, Pasan, Pandaripani, Lenga, Lad, Madanpur, Morga, Bera, Senha, Adsara, Podikhurd, Bijadand, Tenra, Telaidand, Amlikunda, Keshalpur, Jatga, Mukuwa, karimati, Basin, Dumarmuda, Nagaikutesar, Kudrai, Muddhowa, Berodkhar, Chindpuri, Chindiya, Lamna, Kodgar, Sarbhonka, Tanakhar, Ghonsra, Puta, Sukhrital, Dumarmuda, Navapara, Khara, Sarma, Sarisamar, Sadamar, Semra, Chandroti, Keshalpur, Tuman, Ghaghra, Baghindand, Kotmara, Pipariya, Tenra, Jelke, Amjhar in Katghora Forest Circle.*

(a) The complete process for identification and settlement of rights under the FRA has been carried out for 20.342 Ha. Forest Land, & 1.089 Ha. of Revenue forest land, Total Area 21.431 Hectare land area proposed for diversion.
