The Online application vide ref (i) has been scrutinized and submitted to Principle Chief Conservator of Forest/Chennai already for which the Part II & Part III portion have been uploaded by District Forest Officer/Kanchipuram and Chief Conservator of Forest/Chennai vide ref (ii) & (iii) respectively.
2. Now, Principle Chief Conservator of Forest/Chennai has requested to rectify certain defects in the said proposal vide ref (iv) for which the following are submitted,
  - a) Initially we have submitted the proposal for diversion of 6.026ha of Forest land in Paranur Reserve Forest and Thirutheri Reserve Forest of Chengalpet Forest Division for erection of 230 KV DC transmission line from Cuddalore to Veerapuram.
  - b) Later the tower location 56/0 (1 No of tower) which was proposed to erect in Paranur Reserve Forest has been shifted to near by lake (Non forest area) as per site condition. Hence, the site position of tower location 56/0 has not been indicated in details submitted & uploaded.
  - c) Hence, the length of said line passing through Reserve Forest area has become reduced and the line will be erected in Thirutheri Reserve forest only.
  - d) Now, the area of forest land to be diverted in Thirutheri Reserve Forest is,

1100m x 46m =50600 sq.m (or) 5.06 ha

3. Hence, the area of forest land to be diverted and required for erection of 230 KV DC transmission line from Cuddalore to Veerapuram in Thirutheri Reserve forest is 5.06 ha only for which the proposal may kindly be modified and uploaded at the earliest by considering the importance of said scheme in view of interest of Public.
4. Further, it is brought to your kind information that the entire line works is almost completed except this forest land in Thirutheri Reserve Forest Please.
