SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF

(For the Forest land to be diverted under FCA)

A proposal has been received from PUBLIC WORKS DEPARTMENT FATEHPUR for diversion (under FCA-1980) of 0.9060 ha. of Protected forest land of Rajas Forest block, Range Laxmangarh, Division Sikar for non forestry purpose. The subject envisages the use of forest land for Diversion of 0.9060 ha. of forest land for CONSTRUCTION OF MISSING LINK ROAD FROM "LAXMANGARH - SALASAR TO RAJAS VIA CHOUHANO KI DHANI, GOURU KA BAS, KHEJAROLIYAN KI DHANI & MIYAN KI DHANI". The site inspection of the land involved in the proposal has been done by me on dated 08.10.2021

On inspection of the site, it is found that the land required by the user agency, is a forest measuring 0.9060 ha. of Protected forest block Rajas of Range Laxmangarh. This road is Proposed in 0.9060 ha.

The requirement of forest land as proposed by the user agency in Col. 2 of part-I is unavoidable and is barest minimum required for the project.

Any rare/ endangered/ unique species of flora and fauna are not found in the area.

Any protected archaeological/ heritage site/ defence establishment or any other important monument is not located in the area.

The user agency has not violated the provisions of Forest (Conservation) Act, 1980 and no work has been started without proper sanction.

A. Presently User agency has not violated the Forest (Conservation) Act, 1980 and no work has been started without proper sanction.

B. (i) This road passes through an area of 300 mts of SDS Rajas 25 ha. Plantation of year 2020-21 . So an area measuring 300 mt x 10 mt i.e. 3000 sqm. passes through the plantation area. As a result of which 150 plants are likely to be disturbed/destroyed.

(ii) As 300 mt distance passes through the plantation area, safety of the plantation is required for which Angle iron, Chainlink fencing. Chain link fencing also proposed on the boundary of forest to avoid the possibility of encroachment.

Total expenditure likely to be incurred on the above is as follows :-

(i) Expenditure on 150 plants till date -	8390.00
(ii) Chainlink fencing 300x2 mt (600mts)-	105900.00
(iii) Chain link fencing on the boundary of forest land to avoid the possibility of encroachments.

hence an amount of Rs. 3,81,688 (Three lakh eighty one thousand six hundred eighty eight only) is to be levied on PWD Fatehpur for the above mentioned works.

C. This Missing link road from LAXMANGARH - SALASAR TO RAJAS VIA CHOUHANO KI DHANI ,GOURU KA BAS, KHEJAROLIYAN KI DHANI & MIYAN KI DHANI is useful for the villagers of Rajas and other villages. It is public utility work, hence this proposal for diversion is recommended.
