

(v) Legal Status of Forest	The Proposed project area is passing through Gaya-Wazirganj-Hisua (NH-82) road and has been notified as Protected Forest for management purpose by Environment, Forest and Climate Change Department, Government of Bihar vide S.O. No. 400 dated 31.12.1996. (Notification annexed as annexure I)

(ix) Approximate distance of proposed site for diversion from boundary of forest	The proposed project area is passing through Protected Forest area along Gaya-Wazirganj-Hisua (NH-82) road.

No. The proposed project area is only notified Protected Forest and does not form part of any National Park, Wildlife Sanctuary, Biosphere Reserve, Tiger Reserve, Elephant Corridor etc.
(xi) Whether any rare/endangered/unique species of flora and fauna found in the area. If so, the details thereof.	Nilgai is found naturally and free distributed across the Gaya district in the farmlands. Animals like jackal, hair, Common Langur etc are found in the nearest forest areas. The undersigned is of opinion that the proposed project will not affect the distribution or movement of any wild animals found in the area. So far, no case of wildlife damage has been reported on the proposed area. Nevertheless, the crop raiding Nilgai is present in the adjoining areas of the forest boundary.
(xii) Whether any protected archeological/heritage establishment or any other important monument is located in the area. If so, the details thereof with NOC from competent authority, if required.	As per my knowledge, the enquiry report of Forest officials and the information provided by the user agency, there is no record of any protected archeological/heritage site/monument or any other important monument located in the area of the proposed project.

13. Specific recommendations of the DCF for acceptance or otherwise of the proposal with reasons.	<p>This is the bare minimum forest land required for the project. The amount realized from the user agency in the form of NPV shall be utilized for conservation, protection, and management of forest in this division. The green belt will be created through the amount realized from the user agency as Compensatory afforestation work and it will help in the increasing green cover.</p> <p>The proposed area involves diversion of 0.03225 Ha in Gaya Forest Division, Gaya. This is the bare minimum of forest land required for the project and has no other alternative to bye-pass. Diversion of this forest land area for the project (Non-Forestry activity) may not much affect the local flora of the area. The User Agency has not violated the prescribed provisions of the Act till the date of inspection.</p> <p>In light of the above mentioned facts and keeping the cognizance that Gaya District falls under the Naxal Affected area and as per the prescribed provisions, I recommend positively for the approval of this proposal. Therefore this proposal for diversion of forest land may be approved with necessary conditions and directions.</p>
