	(iv) Justification for locating the project in forest area	<p>A new IPH Division was created at Thunag by the HP Govt vide notification no IPH-A-A(1)/2018 Dated 5th Feb,2018 along-with two new sub-Division one at Bagga Chanogi and another at Kelodhar. The administrative control of IPH Sub-Division Bagga Chanogi, Kelodhar, Thunag and Chhatri have been made under this Division. The Divisional and sub-Divisional offices have started functioning at their respective places.</p> <p>Presently, the office of AE Kelodhar is running in a private hired building due to non-availability of Govt. accommodation at this place. So, it has been proposed to construct a new building for AE office. The work appeared in the budget book vide computer code No. 2018-306-151 and 2018-306-153 with a budget provision of ₹ 30.03 Lakh and ₹ 15.00 Lakhs during 2018-19. The A/A &amp; E/S to this work was accorded by SE IPH Circle Sundernagar vide Letter No. 3586-94 dated 17-5-18. Amounting to ₹ 68,11,300/- only.</p> <p>Since, there is no other Govt. Land available for this purpose at Thunag as certified by DC Mandi in NAC. As such it has been proposed to construct this building in forest land. Owing to this reason it is necessary to divert forest land for non-forest activity.</p>
	(v) cost-benefit analysis	Not required as the area of diversion of forest land is less than 5 hac.
	(vi) Employment likely to be generated	However the construction of the road will be done by "A" Class contractor by using mechanical equipment, yet employment of local people will be given as per policy of HP Govt. as such by taking 30% of the <b>total cost 3003000/-</b> for employment generation minimum employment generation <b>will be 6000 mandays</b> . More important is that by construction of this road the people of this area will get self employment by growing cash crops like foods & vegetables which will boost up their economy.

Purpose-wise break up of the total land required:	<b>0.056 hact.</b> Forest land is required for construction of <b>AE OFFICE AT KELODHAR IN TEHSIL CHACHIOT DISTRICT MANDI.</b> whereas <b>0.0016 hact.</b> Forest land is required for construction of forest land will be required for dumping of the muck extracted by formation cutting of the road in forest land. As such total <b>0.0576 hec</b> land is required for construction of <b>AE OFFICE AT KELODHAR IN TEHSIL CHACHIOT DISTRICT MANDI.</b>
