ORDER:-

In the reference 1st cited, the Revenue Divisional Officer, Kagaznagar has furnished available Government lands for Compensatory Afforestation, wherein the Forest officials have also issued site suitability certificate for compensatory afforestation purpose.

Further, vide reference 2nd cited, the Revenue Divisional Officer, Asifabad has recommended for transfer of Govt. land to an extent of 230.04 acres (93.096ha) in Sy.No.322 of Pangidimadara village of Tiryani Mandal to Forest department under Compensatory Afforestation. The District Forest Officer, Kumuram Bheem Asifabad vide reference 3rd cited, has submitted site suitable certificate for said Government land under Compensatory Afforestation.

In this regard, the District R&B Officer, Executive Engineer, Kumuram Bheem Asifabad has requested to identify Compensatory afforestation land to an extent of **81.1522 ha**, for the works taken up by the (R&B) Department.

Further, the District Panchayat Raj Engineer, Kumuram Bheem Asifabad has also furnished information on requirement of CA land to an extent of **34.31ha** for the works taken up by Panchayat Raj Department in this District.

In this regard, the extent available under CA in this district is 123.356 ha and the details are as follows.

In view of the above, it is hereby ordered to transfer an extent of 115.4622 ha (out of 123.356 ha) of Government land situated in Bejjur & Tiryani Mandals to Forest Dept., for providing the same under compensatory afforestation purpose. Balance CA land is available in Sy.No.64, Extent: 7.8938ha in Talai village of Bejjur Mandal.

The concerned Tahsildars are instructed to handover possession of the above lands to Forest Department under cover of panchanama and Zimmapatrak and report compliance.

The District Forest Officer, Kumuram Bheem Asifabad is requested to take over possession of the above lands from the Tahsildars, immediately.
