Bhowah Land Lease cleed between the Deputy (9)

THIS INDENTURE made the tenth day of July, 1924 (Nineteen hundred and twenty four) BETWEEN the Deputy Commissioner of Naini Tal (on behalf of the Right Honourable Secretary of State for India in Council, hereinafter called the "LESSOR") of the one part AND The Roman Catholic Bishop of Allahabad and his Successors in Office (hereinafter called the "LESSEE") of the other part witnesseth that in consideration of the NOMINAL rent hereby reserved and of the covenants on the part of the Lessee hereinafter contained, the Lessor doth hereby demise unto the Lessee all that plct of land containing byy measurement 9.33 (nine and thirty three) acres FORMERLY in Bhowalis back Compartment Nos. 19, 20 and 25 Naini Tal Forest Division bounded by pillars as per detail in the attached description of the boundary ar for the sake of greater clearness delineated or shown on the plan hereto attached and thereon coloured.

TO HOLD the same unto the Lesses for the term of ninety (90) years from the first day of July 1924 rendering threfore during the said term a NOMINAL rent of rupees five (Rs. 5/-) payable before or on the 1st July 1924 at the Office of the Deputy Commissioner of Naini Tal.

And the Lesses hereby covenants with the Lessor as follows:

1st: that the Lessee will during the term hereby granted pay unto the
Lessor the yearly rent hereby reserved on the day and place hereinbefore appointed.

2nd: that the Lesses will use thesaid demise premises for the purpose: of erecting a Church, Priest House, School, Teachers and servants quarters.

Ind: that the Lessee will be responsible for the action of his men and servants if they do any kind ofdamage to the surrounding forest. Care must also be taken to protect the water pipes which cross a the area. If it is necessary for building purpose to DIVERT them this must be done at the cost of the Lessee. If the pipes are covered over in any way this must be done in such a manner that they can easily be got at whenever repairs become necessary.

with: that the Lessee will on the expiration of the term of his lease peaceably surrender the said demised to the Lessor: PROVIDED:

- a) that the Lessor will on the expiration of the term of this lease if the demised land be NOT otherwise required by the Lessor, GRANT to the Lessee a fresh lease of the said land for a further period of ninety (90) years, and so on.
- b) also that upon the expiration of the term of this lease or of any renewed lease, which may be granted as aforesaid, the Lesses shall be allowed such period as to the Lesses may seem sufficient, NOT being less than twelve months, within which to remove any buildings which he may have erected or any materials which wa he may have brought upon the demised premises, BUT upon failure to remove the said building or materials within the time so limited the same shall become the property of the Lessor.
