Sub: FORESTS – Kancheepuram District – Chengalpattu Division – Proposal for diversion of **Forest land in Nallur Reserved Forests** for widening the existing approach road leading to **Sri Sairam Engineering College** and other Educational Institutions managed by **M/s. Sathagiri Educational Trust** – Online proposal – Revised report called for - submitted.

We wish to submit that based on our earlier **Online FC Act 1980** proposal, in the reference 1st cited above the **Principal Chief Conservator of Forests** in his reference 2nd cited above has directed the **District Forest Officer, Kancheepuram Division** to Scrutinise Our Proposal with reference to Forest (Conservation) Act 1980 guide lines and other Act and Rules in-force and take necessary action within the timeline prescribed in the Act.

In Compliance with the direction of the above orders of the **Principal Chief Conservator of Forests**, the **District Forest Officer, Kancheepuram Division** with his Staff inspected the Forest land proposal for diversion on **04/09/2018** and noticed minor variation in the field extent with reference to the details of area already uploaded by the User Agency vide his letter No. **D/1283/2016 dt: 19/09/2018.** Hence, the **District Forest Officer, Kancheepuram** rightly and promptly requested us to upload revised details of the actual area required and related documents.

As directed by the District Forest Officer, Kancheepuram Division, Our **Sathagiri Educational Trust** measured and assessed the additional area / extent of Forest land as **0.08 hectares (40m length X 20m breath = 800 sqm)** that is essentially and emergently required / needed for Education-related developments such as Connectivity of the College Campus Front Gate approach area in addition to the earlier proposal area of 0.56 Hecter.

In view of the above developments, it is appropriate to mention here that the total area / extent of Forest land **NOW** required by our Sapthagiri Educational Trust is **0.64** Hecters for widening of our existing approved access Road to our **Sri Sairam Engineering College** and other Educational Institutions as furnished below:-

Stretch 1 = **0.56 Hecter**

Stretch 2 = **0.08 Hecter**

Total = **0.64 Hecter**

In view of the above requirement of area for widening of our access Road to our Colleges, the area of Diversion wherever appears in the earlier FC Act proposal may please be Read as **0.64 Hectere** of forest land instead of **0.56 Hectere**.

A Revised Road map for widening of the existing Road – indicating Stretch - 1 as **0.56 Hec** and the additional area required as Stretch - 2 for **0.08 Hec** is enclosed herewith along with other related documents as requested by the District Forest Officer, Kancheepuram Division.

It is submitted that Our present requirement of total Forest land for diversion is **0.64** Hecters. For the above Revised / enhanced extent of area, Our Trust obtained **REVISED Tribal Rights Certificate** from the **District Collector**, Kancheepuram and submitted herewith for your kind perusal and further action. (copy enclosed) The earlier **CERTIFICATE** may be treated as infructuous:


As a consequence of the above of enhanced requirement of diversion of **0.64** Hecters of Forest land, Our Trust is ready to provide **double** the extent of Non-Forestry, our own patta land of **1.28 Hecters** as '**compensatory land**' in the same location with **Geo Reference** of **Perunthandalam** Village in Survey No.218/2 part with Forest boundary of **Anjur RF** in Chengalpattu Forest Range of Kancheepuram Division. The details of Double the extent compensatory land and component wise details of Forest land required by us are enclosed herewith for your kind perusal and action.

WE, therefore Request your Goodselfs Sir that Our **ONLINE** Application / Proposal may Read as Revised extent of **0.64 Hec** for Diversion of Forest land may kindly be recommended to Government for the most helpful **ORDERS** WE sought for.
