3	NOC of concerned departments need to be provided.	Road water works is a part of line. NoC from PHED Deptt is hereby enclosed and there is no involvement of other Deptt like NHAI, Railway etc.
4	List of tree to be actual felled needs to be provided separately.	As the line is already in service and maintaining proper clearance, So number of trees to be actually felled is nil.
5.	As per Working Plan. The area falls under Wildlife Management Working Circle. Hence comments of CWLW are required.	Process for seeking comments of CWLW is in process.
