6 i) Revised Check List 3 and 9 is annexed at page no 6 and 7.

ii) The forest land .02898 ha. has already been diverted in favor of user agency for mining and installation of stone crusher vide Moef&CC letter no. 9-HPB-414/1997-CHA/3593 dated 18-08-2006 for 15 yrs. But due to lapse of period of mining lease period in March 2014. The operation has been stopped. Now the user agency has file renewal proposal no. FP/HP/IND/35171/2018 dated 30-08-2018 and proposal no. FP/HP/MIN/34194/2018 for fresh mining lease.

iii) Revised Digital Map/Sol Toposheet is annexued at page no 8 and KML in CD is enclosed.

iv) The component wise breakup shown in para B 2.4 onlinehas been reconciled showing safety Zone area.

v) Undertaking of user agency in this regard is annexed on page no. 9 and certificate of concern Patawri is annexed on page no 4.

vi) The safety Zone area in this proposal as calculated in approved mining plan comes to 0.5488 hac. The plantation scheme one and half times of the safety zone area has been prospoed in UF-Shandal.

vii)The KML file has been uploaded online and the soft copy (CD) is enclosed herewith.

The NOC of Gram PanchyatRacholi has already been submitted vide previous letter dated 16-07-2020







DETAIL NOTE ON THE PROJECT

GOI, MOEF vide Letter no 9-HPB 414/1997 Dated 18-08-2006 has accorded approval for diversion of 0.2898 hac of forest land for mining purpose in favour of Smt Kanegtu Devi Prop Bushahr Laghu Udyog. The Stone Crusher is already installed at Khasra no 38 since year 1985 and operation are stopped due to expire of mining lease since March 2014. Crusher is established with in 100 mtrs of the proposed mine site. Now project proponent want to run the said crusher for which the sufficient quantity of material is available in the nearby forest land. Hence, an area of 2.1532 hac of forest land has been proposed for diversion under FCA 1980. The proposed mining area is located at khasra no. 13/1(measuring 1.4612 hac for mining aera), and Khasra no 14/1(measuring 00-34-00 hac for approachable road) & Khasra no 22/1(measuring 00-27-36 for stacking) 22/2(measuring 00-07-84 hac for approach road) total 00-35-20 has additional area proposed falling in Mauza-Pashada, GP Racholi, Tehsil Rampur, Distt Shimla Himachal Pradesh. The said area has appraised by joint inspection committee, Geological wings of Dept. of Industries (Govt. of HP) and on the basis of report letter of Intent has been issued vide letter no. Udyog-Bhu(khani-4)Laghu-9/2015-5890 dated 26/08/2017.

After running of the Said crusher it will fulfill the demand of grit in whole Rampur division or construction of roads, bridges, buildings and Dam. These development works are paving boost to the economy of local people. Most of the people now prefer to construct the RCC building for their residential purpose for which grit and sand is he basic need. The timber requirement for RCC is less as compare to primitive method of the house in the area. This will compress the demand of timber from nearby forest in which they are presently having settlement right. After establishing the project it will generate local employment in direct and indirect way and also

Justification for locating the Project in forest land

The proposed mining area is located at khasra no. 13/1, falling in Mauza-Pashada, Tehsil-Rampur, Dist.-Shimla, Himachal Pradesh, measuring 01-46-12 (Govt. Land). The said area has appraised by Joint inspection committee, Geological wings of Dept. of industries (Govt. of HP) and, on that basis of report, letter of Intent has been issued vide letter no. Udyog-Bhu (Khani-4) Laghu-9/2015-5890 dated 26/08/2017. The proposed mining area is demarcated protected forest (DPF) land which covers with native bushes. The minerals i.e. Stone is available in sufficient quality in the applied for lease area to feed the already established stone crusher. The mineral available in the area is suitable for mining purposes. After the extraction of stone, mining area will be developed for the plantation. Project will generate local employment in direct and indirect way. It will also generate the state revenue. It is pertinent to mentioned here that out of mine lease area, Khasra no. 14/1 (0-34 ha) and 22/1 (0-35-10 ha) has additional area propose for the approachable road and raw material stack respectively. Crusher is already established about 100 meters of proposed mine site. With consideration of foresaid matter, it is justified that proposed mine area, raw material stacking area and approachable area to crusher site are required. The operation will be run sustainable process.
