As per the data of Dept. of Public Health & Engineering Dept., Govt. of Madhya Pradesh, Sulibardi Village is 'Dark Zone' implies no ground water availability. Practically we tried two borewells, but there is absolutely no water available.

Only seasonal availability of water during monsoon period. During other part of year, water is supplied through water tankers which makes is necessary to provide for pipeline from nearby malipura for round the year availability of water.

As no source of water is available in sulibardi for round the year supply of water, we request you to kindly provide for permission to lay pipeline from nearby Malipura water source upto Sulibardi.
