### JUSTIFICATION OF PROJECT IN THE FOREST AREA

The objective of project is to supply water for drinking and other purpose upto Sulibardi village to the location of Tourism project of Madhya Pradesh Tourism Board (MPTB). The pumphouse and other machinery are proposed to be constructed and planned at MPTB land at Malipura Village near the water body. The pipeline connecting the 'pumphouse' to the sulibardi end location is passing through forest area that comes under Dhamnod range component 'P515'.

The reason for proposed pipeline are as follows:

- 1) Absolutely zero water availability (both surface and ground water) in sulibardi village, no nearby source to supply for round the year water.
- 2) No other alternative way available to bypass the forest land.

The main positive impacts of the project as planned are:

- It's a Government of Madhya Pradesh, Dept. of Tourism, and Project to promote Tourism in Mandu.
- **Availability of drinking water** – Will provide for facility of drinking water for the locals of village sulibardi.
- Will provide better tourism infrastructure in the region.
- **Employment generation** – it is estimated to generate more than 200 persons employment directly and equally or more as indirectly.
