**Sub : Letter of Intent for proposed A Site Kisan Seva Kendra (KSK - Corpus Fund) dealership at KADRABAD Distric  
BIJNOR State Uttar Pradesh under PMP/Govt Pers (Open) category.**

We refer to your application for award of Kisan Sewa Kendra dealership and subsequent interview held on 25.11.2010. It is intended to offer you the A Site Kisan Sewa Kendra dealership of Indian Oil Corporation Ltd on the following terms & conditions:

1. You had indicated & requested in your application that you would like to avail the facilities (land & Infrastructure) provided by the Corporation and accordingly, to enable you to operate the dealership, we will develop the said Retail Outle at **KADRABAD**
2. For the facilities that may be provided by the Corporation as aforesaid, we will recover from you license fee as may be decided by the Corporation and applicable from time to time.
  - i) At present, up to a combined sales volume (MS+HSD) of less than 600 kl in a financial year, the license fee recovery shall be Nil.
  - ii) On achieving combined sales volume( MS+HSD) of 600 kl or more in a financial year, license fee shall be recovered from the first month of the next financial year. At present, the license fee recoverable is Rs. 43 per kl on MS and Rs. 36 per kl on HSD plus applicable taxes in this regard.
  - iii) After commencement of license fee recovery, even if the sales volume drops below the minimum combined sales volume( MS+HSD) of 600KLPA, the recovery shall continue as per ij) above.
3. The Corporation will not be held liable for any loss or damage on account of delay that may occur in providing you the facilities mentioned above, whatever may be the cause of such failure or delay.
4. After completion of facilities required for commissioning of Kisan Seva Kendra , you shall immediately make all financial and other arrangements and within a period of one month obtain Retail Selling License and other permits / permissions / licenses that may be necessary for commissioning and operating the dealership as may be required under any Central / State Govt. / Municipal or Local Authorities for the time being in force.
5. This letter is merely a Letter of Intent and is not to be construed as a firm offer of dealership to you. The dealership to you will, on your complying with the conditions spelt out herein above be confirmed / formalized by an Appointment Letter and followed by the signing of the Standard Dealership Agreement( a copy of which can be obtained from this office).

6. If already employed you will have to submit acceptance of resignation letter from your employer, prior to the issuance of Appointment Letter by us.
7. If we find that the progress being made by you towards the above is not to our satisfaction, this offer is liable to be withdrawn.
8. Applicable for Corpus Fund Category Only.
  - (a) Working Capital, as may be determined by this Corporation at its sole discretion, to be utilized only for the purpose of taking delivery of MS / HSD from this Corporation to maintain supply.
  - (b) The above Working Capital will carry an interest @ 11% payable monthly from the date of disbursement of the Working Capital by the Corporation.
  - (c) The aforesaid Working Capital with interest will be repayable by you in 100 equal monthly installments, commencing from the 13th month of commissioning of dealership.
9. The LOI will stand automatically withdrawn and cancelled on the happening of any of the following events:
  - (a) If it is found that you have suppressed and / or misrepresented any material facts in your application submitted for award of subject dealership.
  - (b) If it is found that you are convicted for any criminal / economical offence involving moral turpitude.
10. You will not change the constitution/legal entity of Kisan Sewa Kendra dealership without prior written approval of the Corporation.
11. You will always abide by all requirements set forth by the corporation including those relating to quality, quantity, customer service & branding initiatives like XTRACARE as applicable from time to time.
12. In addition to petroleum products, the operation of Non fuel facilities or any other income generating activities at Kisan Sewa Kendra shall be the prerogative of the Corporation and you will abide by the model developed for the said purpose.


