In the meanwhile the D.F.O., Keonjhar Division, Keonjhar has furnished the revised guideline of MOEF&CC, Govt. of India on allotment of land for compensatory afforestation vide F.No.11-306/2014-FC dated 07.10.2014 which is communicated to you vide this office memo no.1623/Rev.Dt.2.7.2015, stipulates that in cases where the non-forest land or the revenue forest land proposed to be utilized for CA is to be provided by the State Government, Uploading/submission of a copy of letter from the concerned competent authority in the State Government stating that land identified for CA will be transferred and mutated in favour of the state forest Department for creation of CA immediately on receipt of stage-I approval under the FC Act for diversion of forest land required by the project proponent will be sufficient


In view of the above, allotment of non-forest land from the Dist.land Bank for raising compensatory afforestation in favour of State Forest & Environment Department on payment of premium/land cost by the user Agency/Project proponent may not be required at this stage. However the premium/land cost shall be realized at the time of alienation of the land after receipt of stage-I approval by the MOEF & CC, GOI.

You are therefore requested to submit a letter mentioning the land schedule of the proposed non-forest land after transferring the same from A.A.A.Khata to A.J.A.Khata along with a copy of the R.O.R, a report on the present position of the land and a letter of consent to pay the premium at the time of alienation of the land in favour of the State Forest & Environment from the project proponent, so that a letter to D.F.O can be communicated as per the revised guidelines of MOEF&CC stated above.

Further you are requested to report if the project proponent fails to submit his willingness in written to pay the premium so that the proposed non forest land may be offered to other project proponent

Submission of the Revenue Misc.Case record instituted for the purpose is not required.
