Subject: Proposal for grant of permission for laying Optical fiber cable along the routes Dane wala to shatir wala via kheo wali Dhab, Jand wala mira sangla Total length 10.300 km

Reference: Your office letter No. RJIL /OFC/ROW/NLD Dated. 31-07-2018  
Your office letter dt 06-09-2018.

As per your request, and on submission of Bank guarantee by agency and on recommendation of Sub Divisional Engineer provisionaly permission for laying of laying Optical Fiber Cable on Dane wala to shatir wala via kheo wali dhab, jand wala mira sangla lenght 10.300 km is hereby granted subject to the following conditions:-

1. OFC cable should be laid at the PWD land limit i.e. at the adge of right of way.
2. The Agency shall furnish a Bank Guarantee @ 50/- per running meter with a validity of one year initially. The length of the section is from Dane wala to shatir wala via kheo wali Dhab, Jand wala mira sangla Total length 10.300 km. Therefore the Bank guarantee amount works out Rs. 5,15,000/-. The Bank guarantee should be furnished in the name of Executive Engineer, Constn. Divn PWD B&R Br Fazilka.
3. In case any shifting or alteration in the position of the laid optical fibre cable (OFC) is required due to widening of highway and constructing of fly over bridges etc license will shift the same at his own cost at a later date within specified period.
4. Agency shall ensure safety and security of all underground installation/utilities facilities and shall be responsible for compensation/identifications of concerned authority for damage caused/claims or replacement sought for at the cost and risk of the Agency.
5. The cable may be laid along with the bridges as per instructions/permission issued by the Ministry of Head Transport and Highway vide their letter No RW/NH/34066 /2/95/S&B dated 25.10.99.
6. Agency will be liable to give a notice of 15 days with route details prior to trenching for fresh or maintenance repair work shall be furnished by the Agency.
7. The period of validity of permission shall be coordinate with the validity of license.
8. The clause of the agreement conditions should be strictly followed.
9. The cable may be laid as per instructions/guidelines issued by Chief Secretary, Local Govt. vide No.19531-39 dt.8.9.2000 and instructions issued by the Ministry of Surface Transport, New Delhi vide their memo NO.RW/NH-12037/826-98 dated 17.8.1999 and Govt.of India Ministry of Surface Transport Deptt. of Road Transport and Highways vide their memo No.RW/23044/17/2000-B&R dt 9.9.2000. & Secty Govt to Punjab memo no 8/44/2012/-3ES3/ 4580 dt 15.11.2013
10. The Agency wil fill and compact earth in trenches properly as per PWD / MORT&H specitication in case of failure it will be done by the department at his cost and the cost will be deducted from the Bank Guarantee.
11. No damage is to be done to the road & road berms except for which B.T.bill is already submitted.
12. In case of any damage to the plantatiion or any other property of Forest Deptt. The agency itself will be responsible for that.
13. Agency will take NOC from Forest Department and from other respective agency before starting work.
14. In case of any litigation/court case this permission shall be deamed cancelled.
