Subject: - NOC Proposal for creation of LILO of 132 kv line on D/C Tower from 400-kv S/Stn. Dhanunda to 132 kv S/Stn. Kanina.

Ref: - Your office memo no. 975 Dated 16/06/2023.

On the subject cited above the permission/NOC is hereby granted for crossing the following Canal as per I.E.R (Indian Electricity Rules) accorded by Superintending Engineer, JLN W/S Circle, Narnaul vide letter No. 10364/3-W Bridge dated 13.10.2023 in favour of HVPNL Narnaul. Details of Canal is as under:-

As per Haryana Government Gazettee Notification No. 32-2017 dated 08.08.2017, permission/NOC hereby accepted subject to the following conditions :-

1. The applicant shall deposit all applicable charges i.e. Processing Fees, Caution Money etc. before execution the work as per amended "Policy guidelines for considering the proposals of private/Govt./Public Sector bodies/undertakings for allowing construction of Road Bridges, Roads and laying of various utility lines (pipelines/cables etc.) across/along the canals/ drains and rivers/rivulets of Irrigation and Water Resources Department, Haryana". The 50% of the caution deposit shall be refunded after satisfactory completion of the work and restoration of the canal/drain/river/rivulet at the construction site and the remaining 50% shall be non-refundable and to be kept by the department as security till the works remains in position.
2. All the fundamental rights in respect to the land will remain with Irrigation & Water Resources Department.
3. Prior intimation be given by applicant well in time before start of work to concerned Sub Divisional Officer/Executive Engineer of Irrigation & W.R. Department.

4. The applicant should ensure in writing for bringing the entire channel to its original shape and design after construction work.
5. The work should be executed by them only in the closure period of the channel so that the irrigation may not suffer. The closure period may be confirmed from Irrigation & Water Resources Department before taking up the work.
6. All the work will be carried out by applicant at their own cost and according to PWD specifications and approved design & drawing under the supervision of concerned Executive Engineer of Irrigation & W.R. Department.
7. The applicant may be directed that all the drawing may be got countersigned from the concerned Executive Engineer and Superintending Engineer in token of hydraulic parameter. Hydraulic Parameter taken in drawing may be got checked before countersign the drawing.
8. Future capacities of the channel be kept in mind and accordingly waterway should not be encroached.
9. The responsibility of the structural stability lies with the executing department. Irrigation & W.R. Deptt. has nothing to do with the design aspects of the structure.
10. Irrigation & W.R. Department will not be held responsible for the design lapse if raised at later stage.
11. After approval of the proposal by the competent authority, agreement shall be executed by the concerned DCO/XEN on behalf of the Governor of Haryana with PGSTL stipulating all the terms & conditions for safeguard the state interest as per the terms of policy.
12. The NOC would be one time and for this particular work only.
13. The maintenance of road & channel in this stretch and protection measures will be taken by applicant during crossing of transmission lines.
14. In case of any breach /eventually occurred in the bank, the applicant shall be responsible for restoration of any damages arising thereof at their own cost.
15. The applicant will be bound to raise the road level if required by the Irrigation & Water Resources Department at later stage. No compensation shall be given to applicant on account of this.
16. All the dismantled material, debris/muck shall be removed by the applicant within 72 hours at their own cost.

17. If there any mishap/losses or any adverse results if occurred as consequences of this road, the applicant will be held responsible for the same and Irrigation & Water Resources Department will not pay anything on this account.
18. The applicant will bound to follow the instructions of the Irrigation & Water Resources Department regarding the safety of Channel etc.
19. If there is any legal action regarding any encroachment, the applicant will defend the same in court and Irrigation & Water Resources Department will not be a party to the same.
20. That Irrigation & Water Resources Department, Haryana reserves the right to withdraw the permission if at a subsequent date it is found that permission is not as per rules or against the interest of irrigation.
21. All other relevant terms and conditions of the approved policy of Irrigation & Water Resources Department will also be binding on the applicant.
