ALTERNATIVE-I

The proposed alternative involves construction of LWSS PC Habitation to Village Haripur & Multi Village Piped Water Supply Scheme of Dehra Block in Tehsil Haripur in Mohal Rajaur in Tehsil Kangra and Mohal Kuthar, Gareru, Balsun, Bhati, Gagehr, Dhar Panyali, Bagrot and Chelian in Sub-Tehsil Haripur in District Kangra. The area proposed for diversion is 1.0041 ha of forest land.

Feature considered:

- The land proposed is barren land.
- Forest land involved to the tune of 1.0041 Hectares.
- No disturbance to the stable slope & green cover.
- No felling of trees is involved in the proposal.

ALTERNATIVE-II

The proposed alternative involves construction of LWSS PC Habitation to Village Haripur & Multi Village Piped Water Supply Scheme of Dehra Block in Tehsil Haripur in Mohal Rajaur in Tehsil Kangra and Mohal Kuthar, Gareru, Balsun, Bhati, Gagehr, Dhar Panyali, Bagrot and Chelian in Sub-Tehsil Haripur in District Kangra. The area proposed for diversion is 1.2100 ha of forest land.

Feature considered:

- The area in question is vulnerable to land-slides thus not suitable for laying Water Supply Schemes
- Forest land involved to the tune of 1.2100 Hectares.
- There shall be disturbance to the stable slope & green cover.
- 12 number of felling of trees is involved in the proposal.

ALTERNATIVE III

The proposed alternative involves construction of LWSS PC Habitation to Village Haripur & Multi Village Piped Water Supply Scheme of Dehra Block in

Tehsil Haripur in Mohal Rajaur in Tehsil Kangra and Mohal Kuthar, Gareru, Balsun, Bhati, Gagehr, Dhar Panyali, Bagrot and Chelian in Sub-Tehsil Haripur in District Kangra. The area proposed for diversion is 1.1650 ha of forest land.

Feature considered:

- The area proposed in this alternative is 1.1650 ha.
- The area proposed for construction of Pump House is in flood level so not safe.
- There shall be disturbance to the stable slope & green cover.
- 18 number of felling of trees is involved in the proposal.

Keeping in view the features and necessity of the situation, the **alternative-I**, which is more suitable and environmental friendly, has been finally adopted.
