With reference to above it is intimated that the Pre Feasibility Report (PFR) of Upper Kurmi SHP for enhanced capacity as received vide your letter mentioned above has been broadly examined based on the hydrological and power studies appended in the PFR. On broad examination it has been observed that the Upper Kurmi SHP on Nanti (Sagori & Shugh) khad a tributary of Satluj River in Distt. Shimla, is technically feasible for an installed capacity of 8 MW.
