- 2. The approval is subject to the following conditions:-
- (i) The work should be completed as per the target indicated in the enclosed technical note dated 04.03.2021. As such there shall not be any cost over-run due to time over-run. Stipulations made in the technical note shall be strictly adhered to.
- (ii) On completion of 50% work, if appraisal of the project shows that it will necessitate revision of the estimate based upon the physical completion of the project vis-à-vis financial expenditure, immediate action should be taken to submit the revised estimate so as to ensure that the sanctioned revised estimate is available before necessity for incurring expenditure beyond permissible limits arises.
- (iii) The advertisement for invitation of tenders shall be done as per Ministry's letter No. RW/NH-34066/14/2018-S&R(R&B) dated 25.06.2018. Invitation of bids



shall be initiated immediately after sanctioning of the project.

- (iv) The bids for the work should be invited through e-tendering system as per the instructions issued vide Ministry's letter No. RW/NH/33044/2/2010-S&RI dated 17/06/2011 and dated 17/11/2011 respectively.
- (v) The guidelines for acceptance of tenders and award of work shall be as per Ministry's letter No. RW/NH-24035/4/2008-P&M/PIC Vol.II dated 23.02.2018.
- (vi) The expenditure during the current financial year on this work as also on the other sanctioned work should not exceed the allotment placed at the disposal of the State Government during the year;
- (vii) In accordance with the order contained in this Ministry's letter No. RW/NH-24035/4/2008-P&M/PIC Vol.II dated 23.02.2018, it would be ensured while accepting the tenders that the overall cost at tender rates including contingencies and agency charges does not exceed by more than 5% of the sanctioned cost. Sanction of the Ministry for the revised estimate shall be obtained where the cost exceeds 5% of the sanctioned cost.
- 3.
