Order:

During the demand for the year 2016-17, the Hon'ble Minister for Municipal Administration, Rural Development and Implementation of Special Programme, among others, has announced that Water Supply Improvement Scheme (WSIS) to Tiruthani Municipality will be taken up for investigation.

2. Based on the proposal of the Managing Director, Tamil Nadu Water Supply and Drainage Board, in the G.O. first read above, orders were issued permitting the Tamil Nadu Water Supply and Drainage Board to take up investigation works for providing Water Supply Improvement Scheme to Tiruthani Municipality in Tiruvallur District.

3. The Commissioner of Municipal Administration in his proposal has stated that, accordingly, the Tamil Nadu Water Supply and Drainage Board prepared the Detailed Project Report (DPR) for the project with River Palar as source. He has further stated that at present Tiruthani Municipality is obtaining potable water supply of 2.05 MLD at the rate of 46 lpcd from the Combined Water Supply Scheme to Arakkonam - Tiruthani municipalities maintained by Tamil Nadu Water Supply and Drainage Board with River Palar as source and WSIS to Tiruthani Municipality-Arungulam Head Works -with Koratalaiyar river as source. Since the Tiruthani Municipality, at present, is getting water supply at an average of 46 lpcd, the need for the source improvement is essential. As the Tiruthani Municipality is not contemplated with Under Ground Sewerage Scheme, 90 lpcd of water supply has to be provided and implemented to fulfill the water demand. In the present proposal of WSIS to

Tiruthani Municipality, it is proposed to draw water from 8 numbers of infiltration wells for intermediate stage and 11 numbers of proposed infiltration wells for ultimate stage.

4. The Commissioner of Municipal Administration has also stated that the following components of works are proposed under this project:

- Connecting mains to a length of 6.41 km and necessary pumpsets.
 - Sump at Athipattu with pump rooms.
 - Pumping main
 - 1 number of service reservoir of 10.40 lakh capacity
- Distribution

5. The Commissioner of Municipal Administration has further stated that the cost of the project works out to Rs.121.70 crore to install and Rs.95.20 lakh to maintain annually. The cost includes 5 years contractors' maintenance. Out of the total estimate amount of Rs.121.70 crore for the project, Rs.62.00 crore has been allotted under Capital Grant Fund (CGF) 2019-20 in the 4th Empowered Committee meeting of CGF and Operation and Maintenance Gap Filling Fund held on 18.7.2019, for WSIS to Tiruthani Municipality and the grant amount will be allocated as below:

2019-20	Rs.1200.00 lakh
2020-21	Rs.2500.00 lakh
2021-22	Rs.2500.00 lakh

6. The Commissioner of Municipal Administration has stated that the Tiruthani municipality is not in a position to service the debt if they borrow loan for implementation of this scheme. Hence he has requested the Government to allocate required funds as full grant as a special case through support so that these schemes can be implemented and put into use as the above local body is highly water starved and in need of separate Water Supply Scheme.

7. The Government, after careful examination, have decided to accept the proposal of the Commissioner of Municipal Administration and to accord administrative sanction to the "Water Supply Improvement Scheme to Tiruthani Municipality at a cost of Rs.109.68 crore to install and Rs.95.20 lakh to maintain annually with the following funding pattern, - subject to the conditions that, any project cost increase in future will not be provided by Government. Operation and Maintenance of the scheme is met out from regular annual maintenance; and any additional amount requested

in future will not be provided by Government:

CGF 2019-20	Rs.62.00 crore (2019-20 : Rs.1200.00 lakh 2020-21 : Rs.2500.00 lakh 2021-22 : Rs.2500.00 lakh)
IUDM	Rs.47.68 crore (2020-21 : Rs.25.00 crore 2021-22 : Rs.22.68 crore)
Total	Rs.109.68 crore

8. The Commissioner of Municipal Administration is directed to place necessary proposal before the Project Sanctioning and Monitoring Committee under IUDM for sanction of Rs.47.68 crore of IUDM share (Rs.25.00 crore in 2020-21 and Rs.22.68 crore in 2021-22) for the above scheme in its ensuing meeting.

9. This order issues with the concurrence of Finance Department vide its U.O.No.54404/Fin (MAWS)/2019, dated 30.10.2019.
