UNDERTAKING/CERTIFICATES

1. REHABILITATION OF MUCK ROLLED ON SLOPES-

It is certified that all efforts shall be made to avoid the rolling down of muck during the construction of this project. In case of muck rolling down, the slopes shall be rehabilitated at the cost of User Agency under the supervisions of Forest Department and the reclamation plan will be prepared by the Department.

2. NON-VIOLATION OF FCA 1980-

It is certified that we have not started the construction work of Tundah-II Hydro Electric Project within the jurisdiction of Forest Division Bharmour in district Chamba of Himachal Pradesh so far. Hence, there is no violation of Forest Conservation Act, 1980.

3. UNDERTAKING: PROPER DISPOSAL OF MUCK-

It is certified that the details of muck generated and its disposal shall be done as per the proposed proposal. 7. **Regarding Reclamation Plan of Store & Stacking of Material:-**

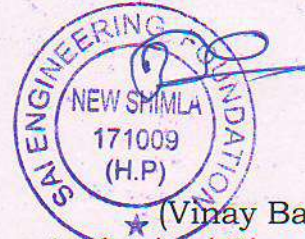
