

i)	<p>Short narrative of the proposals and project scheme for which the forest land is required.</p>	<p>: For diversion of 0.0286 Ha of Forest Land in Sy.No. 10 of Gungal Village of Gungal RF of Yacharam Mandal of Amangal Division of RR District for formation of approach road from main road to reach the agricultural lands in favour of Sri P Praveen Reddy and Others, Hastinapuram, Hyderabad.</p> <p>Until recently, we have a clear approach road to reach our farm lands for cultivation from the Edge (completely at the end and boarder line) of the Gungal RF <b>which was in use since many decades</b>. We, use to utilize this road to reach our agriculture lands and also to transport agriculture products to nearby markets. Due to the recently excavated trench/pit all along the boundary of the Reserve Forest by the Forest Department we were not able to reach our lands, as the existing road is dug out and on account of which we are severely affected both financially and mentally, as the continuous running of agriculture related work is effected and which is the only source of income and livelihood for us and the work-force who are working in the agriculture lands in the pandemic time.</p> <p>We have explored the entire alternatives for formation of road through non-forest land &amp; We do not have any alternative approach road to reach our lands, except for formation of road through Forest Area, which was in use for many decades.</p>
