With reference to above cited Subject, a proposal through web portal was submitted for Bharamasagara LIS, Construction of raising main pipeline (Ch: 36.225 to Ch: 37.550 Km) parallel to NH-48 in Anagodu village of Davangere Taluk & District for approval under Forest Conversation Act-1980.

Further, You have observed under reference letter that distribution line of Bharamasagara LIS passes through Sy. No. 53 of Chikkapura, Hireguntanur Hobli, Sy.No.46 of Nellikatte, Bharamasagara Hobli & Sy. No. 7 of Veeravvanagathihalli, Bharamasagara Hobli, Chitradurga District and these survey numbers are recorded as "Deamed Forest" as per Government order No.RD 106 LGP Dtd: 27-01-1995.

Since, the HDPE pipes are used for which are flexible & can be slightly bent to avoid the particular Deamed forest Sy.Nos by changing the alignment.

It is hereby submitting that alternative alignment avoiding the above Deamed forest Sy.Nos and passing through private Sy.Nos are prepared and the same is marked in the map.

Hence it is hereby requested to consider this modified proposal & send the report accordingly for further necessary action.
