**विषय :** जनपद हरिद्वार के अन्तर्गत उत्तर प्रदेश राज्य के सहारनपुर जिले में, दिल्ली-सहारनपुर-देहरादून आर्थिक गलियारे (ग्राम हरगोवा) से शुरू होकर उत्तराखण्ड राज्य के हरिद्वार जिले में राष्ट्रीय राजमार्ग-334 के बहादुराबाद बाईपास (ग्राम आतमलपुर-बाँगला) तक 6लेन अभिगम नियन्त्रित हरिद्वार के लिए स्पर का उत्तर प्रदेश एवं उत्तराखण्ड राज्य में भारतमाला परियोजना अन्तर्गत विकास के किमी0 19.060 से किमी0 50.700 तक राजमार्ग निर्माण हेतु 1.6535 है0 वन भूमि का गैर वानिकी कार्यों हेतु भारतीय राष्ट्रीय राजमार्ग प्राधिकरण को प्रत्यावर्तन। (Online No. FP/UK/ROAD/147686/2021)

महोदय,

भारत सरकार, पर्यावरण वन एवं जलवायु परिवर्तन मंत्रालय, एकीकृत क्षेत्रीय कार्यालय, देहरादून के सन्दर्भित पत्र द्वारा विषयांकित प्रकरण में 14 बिन्दुओं पर इस वन प्रभाग तथा प्रस्तावक विभाग से EDS के माध्यम से सूचना चाही गई। प्रस्तावक विभाग ने अपने पत्र संख्या NHAI/PIU-RRK/66001/BM/Spur Haridwar/2021/6215, दिनांक 01.10.2022 द्वारा अपेक्षित EDS के बिन्दुओं का निराकरण कर सूचना को इस कार्यालय को तीन प्रतियों में प्रेषित किया गया है। इस कार्यालय तथा प्रस्तावक विभाग से सम्बन्धित बिन्दुओं का प्रतिउत्तर निम्न प्रकार है -

1	In the Form A, Part II and the SIR of the DFO the total area required for the proposal under consideration is mentioned as 1.6535 Ha and the total number of trees affected is mentioned as 285. However, on perusal of the report submitted by the RFO, Roorkee the total area required for the proposal (inclusive of Protected Forest and अधोषित संरक्षित वन) is found to be 3.9062 Ha and the trees involved are found to be 714. The provisions of FCA seem to be applicable to the " अधोषित संरक्षित वन " as well. The State Government is requested to offer their comments on this aspect. The State Government is also requested to clarify the reasons for not including the area of " अधोषित संरक्षित वन " in the proposal and not including the trees falling in the same.	User Agency Replied "It is to submit that the 1.6535 Ha land affected from the project is notified as protected forest by the Uttar Pradesh Government Order No. 4141/XVI dated 15.10.1964 (Copy of Working plan is attached as Annexure-I). The balance 2.2527 Ha area is not notified for any category of forest. Only the plantation has been done by the Forest Department but the land is not owned by the forest department. So the trees affected from the project has been included in the proposal i.e 714 (286 on protected forest & 428 on non-notified land)." The complete detail of affected trees in the proposal is uploaded in part-II, para-13 as additional information detail.

	mentioned at the point No. 7 & 10 of table are not provided. As these sections are notified as "Protected Forests". The details of the area are required to be submitted.	it is to bring to your kind notice that the proposed 1.6535 (Ha). area lies under the jurisdiction of Irrigation Department in the Revenue Records and in this area Plantation has been done by Forest Department in 0.2693 Ha. area the relevant documents are attached in RFO Roorkee's report as <b>Annexure-II</b> . According to the Ministry of Environment and Forest Govt. Letter No. 8B / UCP / 06 / 158 / 2005 / FC / 2054 dated 13-03-2007 (22.4 Ha.) Land from Km. 150 to km. 209 was already transferred to NHAI. <b>(Copy of the same is attached as Annexure-III).</b>
3	As mentioned in the Point No. I the total area <b>(Protected Forest + अघोषित संरक्षित वन)</b> required for the project is 3.9062 Ha (inclusive of the 1.6535 Ha already proposed). If the balance area of 2.2527 Ha also comes under the purview of FCA it should be added in the proposal. Also, the area as mentioned in the point no. 2 if not already diverted be also added to the proposed area and all the relevant documents/information be revised accordingly.	User Agency Replied "The balance 2.2527 Ha area is not notified for any category of forest. Only the plantation has been done by the Forest Department but the land is not owned by the forest department, hence not included in the proposal." The area mentioned in point no. 2, is already diverted to NHAI, relevant documents/ information are attached as <b>Annexure III</b> .
4	Sol Toposheet map of the area proposed for diversion uploaded at Para C in part I is not authenticated. Duly authenticated document is required to be submitted by the DFO.	Authenticated SOI Toposheet map of the proposed diversion has been uploaded in the Form-A Part-1 para-C (iii). <b>Annexure IV</b>
5	At Para C in part I, layout plan is found uploaded instead of the digital map. State Government is requested to upload the correct document.	Revised DGPS map has been uploaded in the Form-A Part-1 para-C (iv). <b>Annexure V</b>
6	At Para D in Part I the benefits of road are described instead of the justification for locating the project in protected forest. State Government is requested to upload the correct information.	The justification as well as benefit of the project has been uploaded in the Form-A Part-1 para-D (i). <b>Annexure VI</b>
7	Details of alternatives uploaded at Para D (ii) (a) are not authenticated. Duly authenticated document is required to be uploaded.	Authenticated document has been uploaded in the Form-A Part-1 para-D (ii) (a). <b>Annexure VII</b>
8	FRA certificate to be is not uploaded. State Government is requested to upload the FRA certificate along with all the annexures at Para K. However, the same may be uploaded prior to the Stage-II approval.	FRA certificate has been obtained from concern DM/DC and uploaded in the Form-A part-1 para-K (i) (a). <b>Annexure VIII</b>
9	It is seen that the density is mentioned as zero at para 4 in part II. State Government is requested to submit the clarification in this regard.	Related area Forest Density has been corrected in para 4 in part II in the Portal.
