Ref:Your letter No.CGM/BBNL/RoW/1, dated:21.06.2014, addressed to the Additional Chief Secretary, RD and PR Department, Government of Karnataka, Bengaluru.

I am directed to invite your attention to your letter under reference on the subject cited above and to stale that the Department of personnel and Administrative Reforms(e-Governancee, Government of Karnataka, has already issued orders as contained in the Government order No.DPAR 79 EGM 2012 dated:14-12-2012, a copy of which(both in Kannada and its English version) is enclosed herewith whereby Government of Karnataka has issued orders facilitating implementation of National Optical Fiber Network(NOFN)Project of Government of India, in Karnataka, for establishing an Optical Fiber based network for Broadband connectivity to Panchayats for Universal Services to rural population of the country.

The said G.O, interalia, designates Centre for e-Governance as the nodal agency to coordinate with BBNL for implementation of NOFN project in Karnataka.

Preamble:

Government of India, in its letter dated 02-05-2012 referred above at read (1), informed to established an Optical Fiber based network for Broad Band connectivity to panchayath of Universal Services to rural population of the Country. This project is called National Optical Fibre Network Project (NOFN). Circular No:ITD06PRM 2012 dated:15-06-2012 as been issued pertaining to this project. Instruction through this circular has been given to the Deputy Commissioners, Chief Executive Officers of Zill Panchayaths, Executive Engineers of PWD, all Electricity Supplies Company, commissioner and Director of Directorate of Municipal Administration and Executive Engineers of Irrigation of all districts, extracted as under:

"All the Concerned Authorities/Agencies/ Department are hereby instructed not to callect Row charges to implement the above project and suitable instruction has to be issued to the concerned under your jurisdiction. The state government is fully committed to support this project of central government.

Deputy commissioner and Chief Executive Officer are requested to provide space of not less than 50 sq.ft., free of cost and ensure mains power in the Gram Panchayat Office/ suitable location for installation of equipment of the NOFN project. Ensure that the BBNL staff or their representatives are provided 24x7 access to the facility where NOFN equipment is installed, to enable operation and maintainanace. DCs and CEOs shall nominate in Nodal Officer for Co-Ordination

with BBNL, Executing Agency for the project. Suitable awareness programmes among the local officers and other stakeholders be also organized."

Tripartite MoU on behalf Government of Karnataka has been signed to implement this project in the state.

Government of Kamataka is required to provide support to this Project(NOFN)as per paragraph 6.0, which is reproduced below.

- "6.0 Union Territory/State Government:
 State Government/UT will act as a facilitator for providing NOFN services and will ensure the following
- 6.1 Designate a nodal Department to coordinate with BBNL for implementation of NOFN Project in the State/Union Territory.
- 6.2 No Row Charges including reinstatement charges be levied by any State Government, their local bodies, companies or agencies as the information highway proposed to be created through National Optical Fiber Network for broadband to be connectivity to Panchayats is primarily for the benefit of the local communicates to panchayats and State Governments. This support will be considered as contribution of the State Government towards this project as a larger good for ensuring the time bound implementation of the programme and to avoid any delays in grant of Row-permission.
- 6.3 Electric Utilities (Transco/Discoms) shall give Right to Way (Row) on their transmission lines/sub-transmission lines/distribution lines free of cost to BBNL for installation of OPGW/ADSS cable as my be suitable for extending connectivity to Gram panchayats.
- 6.4. The State Government through its competent authority will issue blanket approval to BBNL authorizing it for laying OFC without further need of Row permission under the State agencies and electric utilities in the State for the NOFN project during installation as well as operation and maintenance phases i.e.life cycle of the project.
- 6.5 The blanket approval of Row should be applicable to the all State Government agencies like PWD/RES/Forest/Municipality/Panchayat authorities/Electricity Boards/Irrigation/Private Electricity Distribution Agency etc. As applicable. (subject to adherence to provisions of Forest conservation Act wherever applicable)
- 6.6 State Government, will provide space and power at Gram panchayat Bhawan or any other suitable location on cost basic for equipment placement and sn ooth operation of the NOFN project as required.

6.7. State Government, will provide unhi.ndered access to BBNL's staff of its representative in Panchayat Bhawan or any other suitable location for operation/maintenance.

6.8 This agreement will be valid for operation and maintenance of the OFC Network"

Further, Government of India has specified, in paragraphs 7.0 and 8.0 of the MoU, the advantages that would accrue to state Governments and Panchayats by establishing the proposed network, which are reproduced below:-

- 7.0 Advantage to State Government
- 7.1 Panchayats are the constitutionally mandated 3rd tier of government and key institutions for local self government in the rural areas. Coverage of Panchayats with Broadband internet connectivity has a great potential for empowering rural masses by giving them access to information, public services including those of education,
- 7.2 Bandwidth requirement for panchayats will be higher due to sharing of connectivity and extensive use of audio/video applications
- 7.3 The network can be used for service delivery platform for payment, enrolment and registration for targeting benefits to BPL category, MNREGA, PDS, certificates for birth/death/income, land records and registration effectively and efficiently by
- 7.4 State government can develop e-office for delivery of document management system, collaborative messaging, e-file, record management, project and task management, RTI, Parliament Questions, court cases, public grievances, inventory and stores, administration, Human resource, budget monitoring, circulars, events, notices, etc. Taking into consideration of Panchayats and rural citizen.
- 7.5 Other applications for the Panchayats are Government schemes, Planning Management, Monitoring, Payments, Education, Health, Employment, Agriculture and Commerce.
- 7.6 Further with the help of central government standardized ICT Systems and Services state government can get robust and reliable National Network, improved efficiency and reduced costs, improved Centre-State co-ordination, improved co-ordination among states, sharing of best practices, better planning, visibility and monitoring of development, enhanced Cyber Security and Data Control, improved public service and delivery at Panchayats and improved productivity efficiency and reduced cost.

8.0 Benefit to Panchayats.

8.1 Citizens resident in Panchayats will get easy and convenient access to public services on education, health, security, employment, agriculture, banking, pension, transport, energy, legal, etc.

8.2 They will get access to and awareness on government schemes in a transparent manner and with transactions in real time, improved Government interface and enhanced Governance experience leading to citizen's empowerment. Accordingly, Government has ordered as follows.

Government order No:DPAR 79 EGM 2012 dated:14th December 2012

Government has ordered as described in the preamble as below:-

To issue necessary orders to directing the departments/institutions concerned to implement strictly as specified in paragraph 6.0 of the MoU to the implementation of NOFN project in the State:-

(a) Necessary help shall given by the government departments/institutions reproduced in para.2 of the paragraph (6) of the MoU as in read (3) above.

(b) The Government departments/institutions should follow the instructions given in para 3 of the circular dated: 15/06/2012 as read (2) above.

- 4.2 To designate the centre for e-governance, Bengaluru as the nodal agency to coordinate with Bharath Broadband Network Limited (BBNL) for implementation of NOFN Project in the State.
- 5. The concerned administrative departments of Karnataka Government secretariat should issue necessary instructions to the field departments/institutions concerned to take necessary actions to implement the instructions given in para 4.1 above.
