Letter under reference in the case ROW permission for laying of Optical Fibre Cable under our jurisdiction on Granting permission for laying of BPCL's Underground 4"/8" Dia steel & 63 mm, 90mm & 125 mm Dia MDPE pipeline (Along with OFC Cable) Along/Across Various Link Roads, RCC Roads in Rupnagar District (To Develop City Gas Distribution (CGD) Network in the appended drawing observed in this office subject to the field report received from the Sub Divisional Engineer, Constn Sub Divn No. 1, Rupnagar. The permission is given subject to the condition derived as under:

- If river/nallah is dry Bharat Petroleum Corporation Ltd is proposed to cross the same by laying GT/RCC pipes at least 1.65 m below the river bed. In case of flowing water where 1 Bharat Petroleum Corporation Ltd cannot cross by horizontal drilling method the same Bridge/Canal will be crossed by clamping method.
- If clamp is not possible, bridge will be crossed by concrete enchased GI pipe laid inside the 2. railing on the edge of the bridge.
- All link roads will be crossed by Augar boring or using trenches less method. In case, if there is any difficulties at a particular crossing Bharat Petroleum Corporation Ltd will 3. 18
- contact departments concerned Engineer before taking up the work. The department shall not be responsible for any loss or damage to the cable etc. that may 4 occur due to any reason during /after laying the same.
- If the event of any mis-happening/accidents etc., while carrying laying of cables Bharat 5 Petroleum Corporation Ltd shall be liable to pay any type of compensation so claimed.
- Bharat Petroleum Corporation Ltd shall not cause any damage to the carriageway of the 6 highway and the structure like bridge, culverts, drains, buildings etc., and in case of failure Bharat Petroleum Corporation Ltd will be liable to make good the loss caused to the department.
- Bharat Petroleum Corporation Ltd shall lay the cable under the guidance of the 7 department.
- The department shall not be responsible in case of the cable line come in the area under 8. development in future at any time. In such an eventually shifting of the cables etc., shall be the liability of Bharat Petroleum Corporation Ltd.
- Bharat Petroleum Corporation Ltd shall be responsible for any damage caused to the 9 trees in the PWD boundary; it will be responsibility of Bharat Petroleyin Corporation Ltd to obtain permission for any such likely foreseen/unforeseen damages from the competent authority.

In case of some un-avoidable circumstances if Bharat Petroleum Corporation Ltd desired to across the carriageway, the same shall be done under the guidance of the department and under no circumstances, the carriageway shall be allowed with pressure

- While crossing the bridge/culverts, no additional dead load shall be allowed to be added to the existing structure. 12
- In case if difficulty anywhere in the stretch, Bharat Petroleum Corporation Ltd shall contact the concerned Engineer of the department. 13
- The permission is subject to the conditions as circulated/Issued by the Govt. of Punjab Department of Public Works (B&R-III) Vide No. 12/34/2013/1 B&R-III 2013 Dated Chandigarh 14-08-2013. If there is any violation in the above said road Bharat Petroleum Corporation Ltd shall bear the load. 14
- The licensee shall not have exclusive right over the edge row. All subsequent applicants will have equal right to use the edge of row, either above or below, or by the side of the optical fiber cable laid by the first user, subject to technical requirements being fulfilled. Whether the technical requirements are fulfilled or not, shall be decided by Government in their sole discretion. In case of any disruption/damage caused to any existing user by the subsequent user, the Government would not be accountable or liable in any manner whatsoever.
- 15 The use of edge of row of State Highways/MDRs/ODRs/LRs will not be permitted for any purpose other than that specified in the license deed, e.g. for Advertisement towers, Statues, Structure, etc. 16.
- The Public Works Department (B&R), Government of Punjab would be the Competent Department authorized to levy and charge fees from the licensee and granting permission for carrying out any of the activities. The charges are liable to be changed, from time to time 17
- The licensee shall be liable to pay charges for damages, if any caused by him to the public property during laying of OFCs or any other services. 18
- The licensee shall be liable to pay charges for damages, if any caused by him to the property of third party during laying of OFCs or any other services and the Govt. shall not be liable to pay for any damage, whatsoever, caused to the property of the third party. In case of any disruption/damage caused to any existing user (third party) by the subsequent user, the Government would not be held accountable or liable in any manner whatsoever.
- The applicant will submit three copies of as proposed layout drawings of optical fiber 19. cables (hard and soft copies) to the concerned officer/authority for verification and record alongwith the application seeking permission for laying of optical fiber cables.
- The cables/pipelines shall be laid underground at approved depth. Any structure above 20 ground shall be aesthetically provided for/landscaped with required safety measures as directed by the Public Works Department (B&R). 21
- The Licensee shall have to provide the safety measures like barricading danger lighting and other necessary caution boards while executing the work. 22
- The grant of license shall be subject to the licensee satisfying (a) minimum disruption of traffic and (b) no damage to the State Highways/MDRs/ODRs/LRs. 23
- The NOC will be treated cancelled if the above noted contents not received in the format of agreement on stamp paper of Rs 300 or as per Govt. norms.8 24
 - If there is any violation in the letter issued by the Govt. of Punjab, you are directed to General Undertaking to abide all the guidelines of the policy/notification no. Infra/guideline/telecom-infrastructure/13546-A Dated 05.12.2013
