Boundary Description:

North 'A' to 'B': Starting from the north west corner, from station No. 123 at 'A' as shown on the map, the boundary line runs in north easterly and South easterly direction through Parampoka No. 99 of village Pasigoan crossing nala between stations 134 and 135, and cutting across cart track Gangapur to Pasigoan between station No. 136 and 137. The boundary line crosses the nala, runs along with the nala till station No. 142 where it enters the parampoka No. 99 of village Gangapur to reach station No. 1 on the common village boundary line of Gangapur and Tungeda. From here the boundary line runs generally in an easterly southerly and north easterly direction through Parampoka No. Nil of village Tungeda cutting across nala, and cart track Dharmaram to Tungeda between station 10 and 11 and through Kharij Khata No. 271, 270 and 253 to station No. 29 at 'B' with the following magnetic bearings and distances.

NOTIFICATION U/S. 19 KUNCHAVELLI RESERVE
No. 181. Dated: 9th June 1952.

In exercise of the powers conferred by section 19 of the Hyderabad Forest Act No. 2 of 1955F. H.S.R. The Nizam of Hyderabad is pleased to notify that the forests falling within the boundaries as described hereunder shall constitute 'Reserve Forest' a month after the publication of the notification in the Government Gazette.

The Reserved forest of 'Kunchavelli' is situated in the Range Yemampalli Tq. Sirpur Dist. Milledad and Divn. Ancheri. It includes the following villages:-

1. Kunchavelli. 2. Kalwada.

Its total area is 476 Acres only.

The notification of this forest under section 4 of the forest act has already been published in Jarida No. 45 dt. 23.11.57F. and under section 6 in Jarida No. 36 dt. 6.9.1958F.

BOUNDARIES

North A-B The boundary line of this reserve starts from point 'A' as shown in the map. This point is situated on the western corner of the parampoka S.No. 172 and on the cart track kalwada to Kunchavelli. From here it proceeds in the north and excluding S.No. 174, proceeds towards the north upto the southern line of S.No. 106. Along with the southern line of 106 and excluding a little area of parampoka S.No. 172 enters in the S.No. 173 with the southern line of the occupied S.No. 558 and excluding a little area of S.No. 172 reaches at the traverse stone after two zig zag where there is point 'B'.

East B-C From here the boundary line takes a direction towards the south-east and crossing traverse line, enters in the boundary of Kunchavelli, including parampoka S.No. 314 proceeds towards the south, south-east and the west along with the southern lines of patta S.Nos. 330-327 parampoka S.Nos. 314 and 317, 315 392 and 314 parampoka finishes at point 'C'.

South C-D From here the boundary line turns towards the south crossing the cart track Kunchavelli to Kalwada and the south-west excluding occupied S.No. 279 reaches at the river. Along with the natural line of river, reaches at the corner of the occupied S.No. 272 in the west where there is point 'D'.

West D-A From here it proceeds towards the north-west and excluding a little area of parampoka S.No. 314 reaches at the corner of occupied S.No. 297. From here it takes a direction towards the north and west and excluding a little area of parampoka S.No. 314, reaches at the occupied S.No. 300. Along with the eastern line of the said No. and excluding a little area of S.No. 314, reaches at the occupied S.No. 304. From here with several zigzags it turns towards the north passing along with the eastern line of the occupied S.Nos. 305, 306, 308, 309, 310, 311, 312, 313 and crossing the traverse line of the two villages Kunchavelli and Kalwada passing with the western line of occupied S.No. 127 and excluding a little area of S.No. 173, reaches at the cart track Kunchavelli and Kalwada. Again from here along with the cart track, proceeds towards the north-west and excluding a little area of parampoka S.Nos. 172, 173 finished at starting point 'A'.

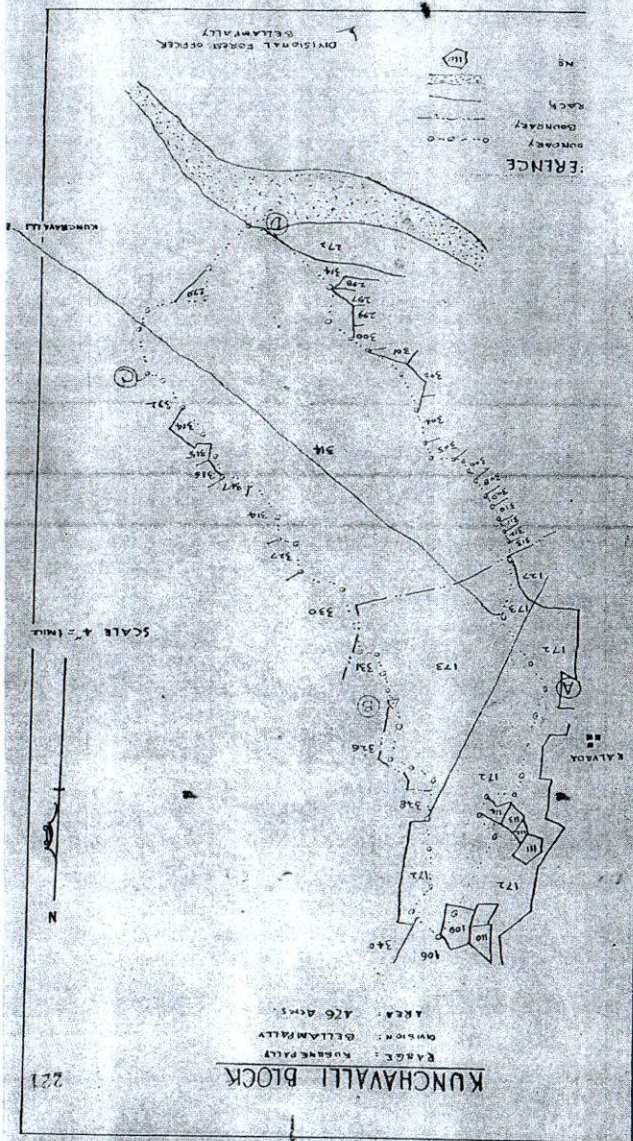
Gairon (pastures).

I. Kunchavelli:- The total cultivated area in this village is 2178 acres 11 guntas, for which the required area for gairon is 218 acres at the proportion of 10%. No gairon has been proposed in the past for this village. Hence S.No. 367 of 260 acres 4 guntas outside the reserve is allotted for gairon. Collector's office has been intimated to act accordingly.

II. Kalwada:- The total cultivated area in this village is 756 acres 37 guntas for which 76 acres are required at the proportion of 10% for gairon for this village S.Nos. 23, 24, 44, 80, 86, 141, 145, 149 of 57 acres outside this reserve have been allotted for gairon previously besides this an area of 96 acres of gairon S.No. 173 of 174 acres has been included in this reserve leaving an area of 18 acres of the said S.No. outside this reserve. Thus the total area of gairon outside the reserve is 75 aca, which is equal to the required area. Moreover 293 of parampoka S.No. 171 and from Kharij khata S.No. and area of 50 acres is outside this reserve.

One cant track passes through this reserve. This will remain opened to the village population and their cattle. They will therefore have the privilege to use the same for communication and for transportation day and night. Particulars of other rights reserved.

1. Raped focha etc., the ryots of Kalvare preferred an application to exclude the gation no. included in this reserve. After investigation the case has been expelled as the gation for this village is settled.

2. Raped focha etc., the ryots of Kunchavalli preferred an application for the s. Nos. 117, 118, 119, 120, 121. In the investigation the said s. Nos. were found outside the reserve. If the boundary line of this reserve passed through any of the above stated numbers it must be connected. The Divisional Forest Officer has been asked to connect the boundary line (if needed) according to IV.

Reserve forest Girelli tq.Chinnur and Sirpur Dist.Adilabad
U/s.19 of the Forest Act no.2 for the year 1355F.

In pursuance of U/s.19 of the forest act No.2 for the year 1355F. it is hereby notified that the forest including the following villages, Kallampalli, Mukidiguda, Jajulpet, Sumpum, Godampet(D) Rajaram, Behampalli Dasnapur, Suraram, Nagaram, Jakkepalli, Nagepalli(D) Lingal, Chittapur, Maddulpalli(D) Veerlapahad Tq.Chinnur and Devha, Digda, Tepergoan, Rampur, Motlaguda, Ravalpalli, Itepalli Tq.Sirpur Dist.Adilabad is declared as R.F. and will come into effect after one month of the publication in the Gazette. It will be called as R.F. Girelli tq.Chinnur of Sirpur Dist.Adilabad. The extent of which is 32200.36 acres and its declaration U/s.7 Gazette No.37 dt.11 thir 1347F and U/s.10 Gazette No.46 in year 1348F was published the following are the boundaries.

BOUNDARIES:

NORTH A to B:- This R.F. first boundary line starts from north-west corner which is shown as 'A' in the map and proceeds to sivar village Loha and corner of Peddavagu where the pillar No.82 is installed and parampoke of S.No.44 is situated. Further it proceeds in zig-zag manner in the direction of north-east upto pillar No.82 to 86 at the distance of 46 chains from there at south-east upto pillar No.86 to 92 zig-zag manner at the distance of 80 chains and at the direction of south-north, east jointly zig-zag way upto pillar No.92 to 113 and 212 chains. From there natural line of Peddavagu upto pillar No.113 to 121 at the distance of 20,30 chains and from there passes through the parampoke S.No.45 touching boundary of Digda. South Oto D:- In continuation of the above mentioned boundaries it deviate to boundary of Yemanpalli and at west parampoke S.No. 34 touching the pillar No.30 to 36 and by the side of S.No.402 cultivable area at the distance of 27 72 chains joins in the boundary of Dasnapur village. From there in the direction of west south in zig-zag way at pillar No.306 1/2 km to 320 in the parampoke No.300 cultivation and by the side of parampoke indulging three nalas and separating track of Dasnapur to Nagaram upto 318 chains and continuing at western side touching pillar No.320 to 330 and in the same parampoke and nala, separating in zig-zag manner joins the R.F. with boundary of Kannepalli at the distance of 165 chains. From there at north west joint line of block Kannepalli and Girelli separating the pillar No. 330 to 335 at the distance of 112 chains joins, at the boundary of Suraram and continuing in the same direction touching the parampoke S.No.38 in between Kannepalli, Girelli blocks upto pillar No.338 to 356, 368 chains where joint R.F. line separates with Kannepalli and joins western boundary. This point has been shown as 'D' in the map.

WEST D TO A: From the above mentioned point R.F. line proceeds by the side of S.No.85 cultivable land at North-east separating Suraram to Yemanpalli track and parampoke of the same village touching the pillar No.356 to 370 in a zig-zag manner touches the boundary of Nagaram at the distance of 232 chains. From there in the direction of east passes in the parampoke S.No.18 and by the side of pillar No.370 to 383 at the distance of 174 chains. From there at North-west proceeding in the same parampoke land and by the side of cultivable lands, or S.No.47, 45 44, 22/1, 31, 24 and cultivated area of parampoke, touching the track from Suraram to Yemanpalli further separating the Nagaram to lingal track and Jakkepalli, upto pillar No.383 to 408 in a zig-zag manner joins at the distance of 360 chains with the boundary of Suraram. From there at west proceeds in the parampoke No.38 and by the side of parampoke, separating the track Suraram to Lingal touching the pillar No.408 to 412 joins with the Jakkepalli boundary at the distance of 78 chains. Further it goes in the parampoke S.No.55 at west, north in a zig-zag way here and there, separating the track of Jakkepalli touching the pillar No. 412 to 428 upto 326 chains joins with the boundary of Nagapalli.

From there at north east proceeds in the parampoke S.No.51 and in the cultivated area and by the side of Jakkepalli and Nagaram track touching the pillar No.428 to 429 joins with the boundary of Suraram at the distance of 27 chains. Further in the same direction passes with in the parampoke of S.No.38 cultivated area and by the side of pillar No.1 to 11 in a zig-zag way joins with the lingal boundary at the distance of 18 chains. From there at the east passes in the parampoke cultivated S.No.33 by the side of Chaitapudi track and separating the same track which goes from Chintapudi to Yemampalli along with the pillar No.11 to 25 in a zig-zag way joins with the chintapudi boundary. Further from there at north-east passing with S.No.113 and separating chintapudi to Girelli track and by the side of cultivable S.No.60 joining with parampoke No.25 to 32 and along with the line natural line and Ferravagu upto No.33 and joins Itapalli boundary. At the distance of 170 chains. From there in the same direction passing along with S.No.66 parampoke the in zig-zag way along pillar No.33 to 34 with the natural line touching pillar No.34 to 49 with the cultivable lands 67,68 by the side of parampoke cultivated and separated the track of Chintapudi to Girelli and joins with the boundary of Girelli at the distance of 320 chains. From there at east in the shape of horizontal line along with the boundary of Girevili and Itapalli upto 264 chains and touching the Motlaguda Jajulpet. From there at north proceeding in the straight line with the boundary of Girelli and Motlaguda as well as Digda and Girelli upto the boundary of Girelli and Digda. From there in the direction of west in a zig-zag way in between pillar No.79,80 proceeds with the natural line and from there along with paddavagu joins upto at the point of 'A' initially from which it starts. For this R.F. no claim was preferred.
