Sir,

This is in reference to your proposal seeking permission for laying of 110 to 400 mm dia HDP/DI pipe line along section of Bhilwara - Ladpura of NH-758 under Chambal-Bhilwara water supply Project Phase-II.

This office vide letter dated 04.11.2015 had forwarded the proposal to Competent Authority NHAI for conveying approval.

The Competent Authority NHAI has accorded approval for laying of pipe line in Ch. 148+880 to Ch. 150+030, totaling to 1150 mt. length and for crossing of NH at 10 various locations.

The Regional Office, NHAI Jaipur vide letter no. 3273 dated 24.11.2015 had conveyed approval of the Competent Authority to the subjected proposal with the following conditions:-

1. The stability & structural safety of the bridges /structures embankment /road crusts etc. while laying & across Storm water drain shall be ensured by the concerned department.

2. Actual work at site shall be started after obtaining necessary clearances of Forest Department or any other related department, if same is required for the proposed work.

3. OFC to be laid at extreme end of 60 m. ROW in the utility corridor only.

4. The work of shifting / relocation of above mentioned OFC, whenever required in future by NHAI shall be executed at your own cost, as per requirement and directions of NHAI.

5. Performance bank guarantee (laying along NH per RM/across NH per crossing) is applicable as per MoRTH/NHAI latest guideline in above location and concerned utility department will deposited the same through BGs before signing the agreement and execution of work.

6. The levy charges for use of NH land has been calculated as per the previous sanction accorded by NHAI

7. In case of any damage to ongoing road work due to shifting of pipeline within ROW, all cost pertaining to repair and the claims likely to be raised by Concessionaire / IE / SE shall be borne by user agency.

8. The work shall be completed in time bound manner by approved methodology.

A copy of the License deed for the use of National Highway land duly signed is enclosed herewith.

You are requested to ensure all the compliance as mentioned in the License deed & conditions sheet.
