

**SITE INSPECTION REPORT (NOT BELOW THE RANK OF DCF)

A proposal has been received by this office from the Chief Manager (Projects) *IHB Limited, Kapoorthala, Aliganj, Lucknow- U.P.* for diversion of *0.080 ha.* of forest land for non-forestry purpose. The project envisages the use of forest land for the purpose of *Kandla-Gorakhpur Petroleum & Petroleum Product (LPG) Pipeline* establishing 1. *Lumbini-Duddhi Road* in between Km. *276.000 to 277.00* Proposal Land *0.23 ha.*, 2. *Azamgarh -Varanasi Road NH-233* in between km *22.00 to 23.00* Proposal Land (*0.023 ha.*), 3. *Audihar-Jaunpur Railway Line* in between Km. *16.000 to 16/1.00* Proposal Land *0.0034 ha.*, for Laying LPG Pipeline. The site inspection of the land involved in the proposal has been done by me on *21.10.2021* On inspection of the site, it is found that the land required by the user agency is the portected forest measuring *0.080 ha.*
