2. Component wise break up details of forest area required for the project area has revised and uploaded in the relevent place in the webportal.
3. Undertaking to bear the cost of felling of trees and transportation cost of the trees to be removed if any available in the alignment path, for the proposed diversion of forest land as fixed by the Forest Department is uploaded and enclosed.

4. Certificate regarding no violation of the provisions of Forest (Conservation) Act, 1980 has been uploaded.
5. Certificate of District Collector, Ariyalur for Settlement of Rights under the Forest Right Acts, 2006 on the forest land proposed to be diverted, is uploaded in the portal.
6. Certificate on non-availability of alternate non-forest land suitable for this project, from District Collector, Ariyalur is uploaded in the portal and demand for forest land for the project is minimum.
7. Forest area for the project is Kanguli R.F. and Tirukkonam R.F. and villages are Silambur and Pukkuzhi.
