1. In reply to point No. 1, authority letter is still uploaded for some other person.	Authority letter is uploaded at Sl. No.- A-3 of form A Part I
2. In reply to point No. 3, VLC proceedings of village Pokhri provided in FRA but the village not mentioned in the village wise break up uploaded online in Part-I.	Surari Tali and Surari Mali are part of Gram Sabha Pokhari. Therefore, VLC meeting had been organized in village pokhari.
3. In reply to point No. 9, copy of map indicating location of alternative examined is still not uploaded in the designated place in Part-I	Copy of map indicating location of alternative route examined is uploaded in the Sl.No.-D of form A Part-I
4.. In reply to point No. 12, CA stipulation against total forest area diverted in the district is still not commensurate and neither justified by the State Govt. The State Govt. in once again requested to correct the information and if required do the proper justification for the poor progress of CA.	N/A (Reply to be given by forest Division)
5 In the DSS analysis it is found that 3.10 ha area is overlapping with the online proposal no. FP/UK/ROAD/9775/2015. The State Govt. may replace this area with some other area suitable for CA and provide/upload revised digital map, Sol Toposheet map and KML file again after making the above chang.	The road project for which the proposal no. FP/UK/ROAD/9775/2015 (Sod -Gajeli-Kagdi-Manglakoti-Pokhri Motor road in Pauri District). had been submitted has now been terminated by the department and proposal for land acquisition has been withdrawl accordingly. Hence there is no need of Compansatory afforestation land for the aforementioned proposal.
6. State Govt. is also requested to provide the original hard copy of all the above-mentioned documents.	The original hard copy of yhe proposal has already been submitted in the comptent forest authority.
