In exercise of the powers conferred by section 32 to the Indian Forest Act, 1927 (Act No. XVI of 1927), the Governor is pleased to make the following rules for the protected forests declared as such by Government notification no. 4041/XIV, dated October 15,1954.

RMXXX RULES

No person shall, without the permission of a Forest officer, do or attempt to do, or cause to be done any of the following acts:

(1) The cutting, sawing, conversion and removal of any tree and the collection, manufacture and removal of forest produce from the protected forests.

(2) The clearing and breaking of land for cultivation of or for making of any threshing floor (khalian) or tethercattle, cructing of any temporary or permanent but or house is such forests;

- (3) The cutting of grass and pasturi of cattles in such forests, and
- 14) The lighting, kindling or burning of any fine near such forests.
