Detailed scheme of Compensatory Afforestation in non forest land acquired under FCA proposal for lion corridor area.

- (2) Description of Area.
Soil type : Muram type, shallow soil depth.
Topography: Hilly area.
Slope:- Sleep
Whether the area is bearing any root stock or vegetation copies growth of Bardi, Khakhara, gorad :- Most of the area is degraded
- (3) Name of Plantation Programme :- Compensatory Afforestation Scheme for Lion corridor area 277 Planting / ha. will be carried out in non forest land of village Dadhiyali
- (4) Scheme of Plantation Programme:-
The Compensatory / Afforestation on non forest land would be started by Dy. Conservator of Forest, Gir (East) Division, Dhari as early as possible after the proposal is formally approved.

The User Agency has given an undertaking to pay the cost of compensatory afforestation as per the preventing wages.

(5) Technical Details:-

Technical details of Compensatory afforestation are as under.

(a) General Details Total:-389 Seedlings /Ha. will be planted

(b) Spacement:- 6 mt X 6 mt for 277 seedling/ha gap planting in soccer plt. 1st year replacement 10%=28 seedling/ha, 2nd year 20%=56 seedling/ha, 3rd year 10%=28 seedling/ha., Total-389 seedling/ha.

(c) Species:- Khair, Arduso, Karmda, Neem, gugal, Gorad, Harmo etc.

(d) Nursery Technique:- Nursery will be raised in polybags of 15 cm x 25 cm x 200mg. of size.
10 x 1 mt. nursery beds will be dug.

- (e) Site Preparation:- Pit of 30 x 30 x 30 as per sanctioned treatment plan.
- (f) Plantation Method (Size of Pit, Ploughing etc.)-45cm x 45cm x 45cm pits to be dug before monsoon 277 plants per ha will then be planted in pits.
- (g) SMC Works:- Chekdam and contour bunds or retaining wall, check wall as per site requirement.
- (h) Protection:- Boundary trench 1m x 0.60 cm x 0.60 cm
Stone wall 1.5m x 1.5m x 1 m will be carried out around the boundary
- (i) Silvicultural Operation:- Three soil working fertilizer irrigation by drip system current years One working irrigation by drip system in one year old and other activity to be done as per scheme
- (j) Maintenance:- Through departmental mans.
- (k) Subsequent silvicultural Operations proposed such as cleaning, cutbacks, thinings etc. (as per species specific requirement) Whenever required.
- (l) Arrangement for people participation (if any) for long term sustenance of the plantations- Departmental staff.
- (m) Proposed monitoring mechanism :- Monitoring will be done by monitoring wing of forest Department

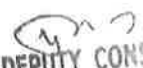

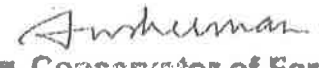
