



जनपद-इलाहाबाद के इलाहाबाद-वाराणसी रेलवे मार्ग(फाफामऊ-जंघई-जफराबाद) कि०मी० 844/12-13 के मध्य गेल इण्डिया लिमिटेड द्वारा प्रस्तावित जगदीशपुर-हल्दिया गैस पाइप लाइन एण्ड एस्पर लाइन परियोजना से प्रभावित क्षेत्रफल 0.025 हे० संरक्षित वन भूमि का स्थलीय निरीक्षण किया गया। निरीक्षण फलस्वरूप प्रस्तावित क्षेत्र में वनस्पति और प्राणीजात की दुर्लभ/विशिष्ट प्रजातियाँ नहीं पायी जाती है, और न तो क्षेत्र में कोई सुरक्षित पुरातात्वीय/पारम्परिक स्थल/रक्षा प्रतिष्ठान या कोई अन्य महत्वपूर्ण स्मारक स्थित है।

SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF
(For the Forest Land to be diverted under FCA)

A proposal has been received by this office from **Gail India Ltd.** For diversion (Under FCA-1980) of **0.025** ha. forest land for non-forestry purpose. The project envisages the use of forest land for **Allahabad Varansi Railway Line(Phaphamau-Janghai-Jafarabad) Km. 844/12-13** in Distt. Allahabad .The site inspection of the land involved in the proposal has been done by me on **22-10-2016**.

On inspection of the site, it is found that the land required by the user agency is a R.F./un-classed/ P.F. measuring **0.025** Ha.

The requirement of forest land as proposed by the user agency in Col-2 part-I is unavoidable and is barest minimum required for the project.(Yes)
