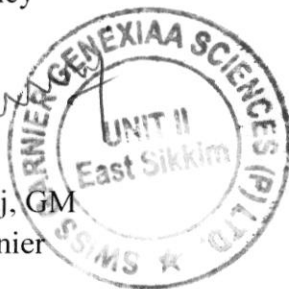

Effluent Treatment Plant (ETP) is found already constructed in the Khasmal Land (as per 1950-52 survey record) which was erroneously recorded as private land in the survey record of 1979-80.
