Necessary comments/ correction is required to be given.	Pertains to Forest Department

The undertaking regarding providing NAC has been found uploaded in additional column detail of online Part-I whereas, NAC has been found placed / uploaded in the proposal folder, un-necessary/ double / contradictory documents should not be uploaded. 5.	The revenue papers along with all relevant documents of the proposal be uploaded in the online portal against the additional column detail of Part-I.	Needful has been done.


