**Sub: Diversion of forest land for construction road from Mari to Dhakkote part- II in Reasi forest division.**

**Sir,**

With regard to the subject cited above while processing of the above mentioned road case the objections were raised by the 40<sup>th</sup> REC meeting of IRO Chandigarh and IRO Jammu on the status of land involved in a construction of above mentioned road. Accordingly the Nodal Officer FCA vide NO. PCCF/FCA/3151/1290-91 dated 24-06-2021 issued directions to the Conservator of Forests West Circle Rajouri to constitute committee of officer Forest, Revenue and PMGSY to ascertain the status of the land falling under the alignment of proposed road.

Further the Conservator of Forest, West Circle Rajouri conducted the joint exercise with Revenue, PMGSY and Forest Officials and report of the same submitted by the Conservator of Forests West Circle Rajouri vide no. CFW-R/649-51 Dated: 28-6-2021 to the O/o the Addl. Pr. Chief Conservator of Forests J&K (Nodal officer FCA) and ~~■■■■■~~ where in the certain observations were raised (copy enclosed) regarding the status of land falling in the alignment of road.

In this context Range Officer Thakrakote was directed vide No. DFO/RFD/1261-62 dated 30-06-2021 to submit a detailed report and also this office approached to the Deputy Commissioner Reasi and XEN PMGSY Mahore vide No. DFO/RFD/1445-49 dated 10-07-2021 to impress upon their staff to submit the report after delineation of the Forest and Revenue boundary.

Furthermore the Range Officer Thakrakote vide No. Th/180-81 dated 09-07-2021 had submitted his report (copy enclosed) with the recommendation that the below mentioned stretches were needed to be incorporated in the revised proposal which are Forest land. The detail is as under:





In reference to the above cited subject matter and reference it is inform to your good self that w/s along with field staff have verified the status of land falling in the alignment of above mentioned road in presence of representative of user agency and patwari Halqua Kalaban/Gundali and patwari Halqua Noera/ thanol under the direct supervision of worthy Conservator of Forest West Circle Rajouri. In this regard it is submitted that all the observations raised by worthy Conservator of Forest West Circle Rajouri have been verified on spot and it is observed that in addition to Forest area detailed in the proposal, the below mentioned stretches were needed to be incorporated in the revised proposal which are recorded as Forest land. The detail is as under:-

Field Inspection Note

**Sub:- Diversion of forest land for construction of Mari to Dhakikote road part-II in Reasi forest division**

This is in reference to the subject matter cited above, the undersigned along with committee comprising of forest, revenue and PMGSY officials conducted on-spot inspection in view of the observation of REC as reflected in the S No. 2 of the MOM of 40<sup>th</sup> meeting dated. 17<sup>th</sup> and 18<sup>th</sup> June 2021 at IRO Chandigarh.

"During the deliberation the REC observed that some portion of road passing through non-forest area appears to be forest land and REC directed Nodal Officer U.T of J&K to constitute a joint team to visit such area of non-forest land on ground and carry out a detailed enquiry about the status of non-forest land appearing like a forest area to rule out any misgivings."

The joint committee was represented by Range Officer, Thakrakote, 2 Patwaris from Kalaban, Neora villages and AEE PMGSY under the guidance of undersigned conducted detailed site inspection on 25.06.2021 and 26.06.2021. Six sites were selected based in revenue documents as well as forest records following field observation. In addition to the forest area detailed in the proposal, the following stretches were observed to be having vegetation which may have to be recorded as forest areas in the proposal. The details are as follows.

- (i) **Kalaban area**:- The under construction road passing though the stretch has been recorded as non-forest area in the proposal. However during the on-site inspection, it was observed to be on the forest land. The alignment in this regard shall be verified by DFO Reasi and submit the report along with violation if any.
- (ii) **Gundall Forests**:- The proposed alignment passing though this stretch is already recorded as forests and as observed from spot it is possible that a patch of Oak/pine forests may have been recorded as non-forests which need to be corrected in the proposal.
- (iii) **Neora forests**:- The proposed alignment passing through two stretches in Neora village which was observed to be forest and necessary correction shall be incorporated in the proposal.



(N) Thanol Forests:- The proposed alignment passing through the Thanol Village is observed to be passing through the one stretch of forests which is recorded as non- forest in the original proposal which needs to be corrected.

Therefore necessary amendments in the alignment after incorporating all the above observations shall be submitted by DFO Reasi. The necessary correction in the revenue documents as well forest records shall be made part of the report. The Geo-coordinates of the alignment inspected by the committee is enclosed for further necessary action.

The direction issued during the detailed on-line discussion held on 28.06.2021 shall be complied and report of the same shall be submitted to this office within 3 days positively by DFO Reasi after making necessary amendments in the proposal.
