Reference to your office letter No. 5528 dated 06.10.2022 on the subject cited above.

In this regard, some observations have been notified by the Regional Officer, Ministry of Environment, Forest and Climate Change, Longwood Shimla, which has been resolved as under:-

1. As per Point No. 1, the project site is UPF-533 Sedan, Marhawag, Jakhari and is the under control/possession of H.P. Forest Department and not declared on protected forest under 1952 notification of Himachal Pradesh Government.
2. As per Point No. 2, the Legal Status of diversion area is a part of U-533 Sedan, Marhawag, Jakhari having 66 hectare area falling in Chil working circle and allotted to PB-IV and khasra/survey component number 17 kilometer stone 160/1. Area from working plan of Shimla forest division statement is attached.
3. As per Point No. 3, the legal status of the (CA) Compensatory Afforestation land that it is a government common land of 12 hectare area falling in the village Seri in Kalzoon Beat, Jubberhatti Block of Tara Devi range (Photocopy of Shimla working plan page 168 & 171 attached) It is a Government waste land declared as PF under 1952 notification of Himachal Pradesh Government.
4. As per Point No. 4, beneficiary villages are marked in the KML file is attached. However, this project will be beneficial to whole state of H.P.
5. As per Point No. 5, the dumping site is one of the components of the layout plan and has been updated/revised the Part-I of the component wise breakup (revised copy of Part-I attached)
6. As per Point No. 6, revised CA scheme is enclosed as per FCA guidelines.
