





I invite attention to the subject and reference cited, wherein M/s. Singareni Collieries Company Ltd., has informed that the mining of coal is site specific as per the geological investigation. The SRP-OC Project geological block was considered for excavation of Coal after sanction of geological report and feasibility report by the Govt. of India. The existing SRP OC Block is proposed for operation upto a depth of 230 Mts and existing depth is 150 Mts and further it is planned to go for depth of 350 Mts towards dip side of virgin patch. Hence, it is proposed to go for expansion in the Reserve Forest area, and some extent in non-forest area, where Coal is available.

Further, the SCCL has informed that the area proposed in the Reserve Forest is 162.45 Ha, and non-forest area is 50.18 Ha. The entire area is covered under valid mining leases of Srirampur, North Godavari and Indaram and requested this office to issue Coal availability certificate in the above area shown the enclosed maps.

As per the Borehole Log provided by M/s. SCCL, the presence of Coal blocks noticed and proposed site is expansion of SRP OC – II, which is an indication that the Coal seams are extended in the surrounding areas.

Hence, it is certified that Coal is available in the area.
