**Subject:** Accord of Administrative Approval for the Construction of New Degree College at Dudu Basantgarh Phase-1<sup>st</sup>.

Government Order No: 311-JK(HE) of 2020

In exercise of powers conferred in S.O. 15, dated: 9<sup>th</sup> of January, 2020 issued under endorsement No. A/PS/DC/2019-62 Dated: 09.01.2020, administrative approval is hereby accorded to the Construction of New Degree College building (G+2) with a carpet area of 29000 Sft at Dudu Basantgarh Phase-1<sup>st</sup> at an estimated cost of Rs 924.16 lac (Rupees Nine Crore Twenty Four Lac and Sixteen Thousand only).

This Administrative Approval is subject to the following conditions:

1. That the proposal is strictly devised and designed as per the relevant code of BIS, CPWD manual, IRC, MoRTH & other relevant codes & Specifications with special emphasis on earth quake resistance of structure.
2. That the structural design of the project is got authenticated by the competent authorities and while designing the latest HFL is also taken into consideration.
3. That any such items not covered under relevant schedule of rates shall be paid in accordance with the set Codal procedure.
4. That there is no time or cost overrun involved in the project and set time line is strictly adhered to.
5. That the NOC from Regulatory Authority & PCB is sought before the commencement of work.
6. That the electrical components are authenticated by the competent Authority before the execution of work takes place.
7. That encumbrance free land is available for execution of the project.
8. That the drawings are authenticated by the competent Authority before execution of the work.
9. That e-tendering mode is followed for finalization of award of the project and working DPR is followed in the advertised BOQ. Fragmentation of project while e-tendering is not allowed.
10. The proper rate analysis and market survey is conducted in light of standing rules and procedures in case of all the items proposed to be executed on ground prior to issuance of formal NIT, in order to ensure rationality of rates.
11. That the Administrative Approval shall neither be construed as any rate approval nor Technical Sanction to the Project.




