1.	From the Perusal of KML file it reveal that most of the portion constructed after 2010, whereas you have reported that road is constructed before 1980. Moreover, KML file is not prepared in polygon shape showing the private land in the different color. Lay out plan and KML file along with the documentary proof that road is constructed before 1980 be uploaded. Working plan prescription may be reviewed. Bill of NPV may be uploaded as per the revised rate. Please scrutinized the complete proposal as per the latest guidelines	<p>1. The Dharli to Balag route has served as a traditional path for people and mules, providing essential access for the residents of Balag to Sundernagar—the primary nearby town offering critical facilities such as healthcare, markets, and educational services. This path was in existence before 1980 and has long been used by villagers for their moment. The path existed prior to 1980 and suffered weather-related damages. Therefore, to keep it accessible, villagers undertook gradual repairs and improvements after 1980 solely to ensure safe passage. These efforts were made without knowledge of FCA requirements or land classifications, serving only to preserve this essential route for the community's needs. To support the historical use, the necessity of this path, and unawareness of the legal status of the land, the affidavits from the locals affirming its long-standing presence and their dependence on it over the years are attached. The PWD after receiving the administrative and financial sanction from the competent authority to construct this road got the area demarcated. Following official demarcation, it was identified that the land along this route is classified as <i>charagah drakhtan</i>, <i>charagah vila drakhtan</i>, <i>gair mumkin Gohar</i> and <i>private land</i>. Given that the violation was driven by the local's necessity, only to the existing traditional path and their unawareness of the legal status of the land, it is requested to consider the case for further processing.</p> <p>2. As per the reply of the user agency the kml file in polygon shape showing the private land in different colours has been prepared and uploaded in the Parivesh Portal part-I. A copy of same is enclosed.</p> <p>3.
