No: 139/C in Kalkuni village has been submitted by the The Parish priest- Infant jesus church, Agasebagil , Ta: Sirsi Dist: Uttara Kannada vide proposal No (FP/KA/OTHERS/35394/2018) for “Construction of catholic burial ground ” in Kalkuni village Sirsi range, Sirsi Taluk of Sirsi Division, Uttara Kannada District.

The Proposed area for diversion has been inspected by me on 25-10-2022 along with Range Forest Officer and staff. The necessary observations have been recorded and enclosed with the proposal. The area proposed for the diversion falls in F.Sy. No: 139/C in Kalkuni village, Sirsi Taluk , Sirsi Division, Uttara Kannada District.

The user agency has submitted, Certificate given by Deputy Commissioner, Uttara Kannada, Karwar for Recognition of Forest Rights (RoFR), Non availability of Non forest land certificate given by Deputy Commissioner Uttara Kannada, Geo-referenced map, topo sheet map of the proposed forest land, justification, necessary certificates and undertaking to bear NPV & CA.
